Stadium Not Likely To Be In City Of Industry

Industry -The proposed stadium's future is looking grim as laws changed, which halted the go ahead of development.

Back in 2011, the Supreme Court ruled to kill local redevelopment agencies which halted

many projects that did not have existing contracts through them, Industry stadium being one of them.

The state ruled that the original contract of the architect and landowner of the Industry stadium, Edward P. Roski, had areas that were not formalized.

One in particular being, where one part of the project would not take place until another was finished. The recent ruling has halted any money from being obtained by Roski for infrastructure, causing a legal battle between Roski's attorney and the state of California.

The stadium also faces the hardship of finding a team as well, Fri., Feb. 14 was the mandated deadline for any teams to file for relocation, which none did so. Without a team and funds prom-

Credit Card Skimmers Caught

Chino – Two suspects were caught and arrested after putting a credit card skimmer device onto a Chase Bank ATM machine and leading a pursuit in Chino. Chino Police Officers arrested the suspects after they fled the alleged crime scene and caused a traffic collision, which injured two others.

Security officials at the Chase Bank located at 12193 Central Ave. called Chino Police Officers to report a suspect that had placed a card skimming device, which is used to capture account and pin information, on an ATM machine located inside the branch.

Officers arrived at the Chase Bank and waited for the suspect to return to collect the device, according to a City of Chino

news release. At approximately 6:05 a.m., a suspect matching the description given by bank officials quickly entered and exited the bank. The suspect fled the scene in a maroon 2000 Lexus GS300 driven by a second suspect.

When Officers attempted

Walnut Man Arrested In Drug Raids

Walnut- Local Walnut man was one of the 10 arrested in the Federal and state drug busts last week.

Walnut resident Steven Huytu Lam, 52, was arrested on Mar 20 in a linked drug bust of marijuana grow houses across three southland counties.

The DEA investigation that was underway had lead to the raid of 26 houses throughout the Los Angeles, Riverside, and San Bernardino counties, 15 of

which were grow houses, and 10 out of 11 arrests. The 11th suspect Andy Tran, a 39-year-old Monterey Park resident, is still at large and being sought by authorities.

According to the U.S. Attorney's Office, the drug trafficking ring would purchase or lease single family homes and convert them into full marijuana farms. The houses featured full hydroponic growing equipment as well as stolen electricity obtained with a sophisticated electrical bypass of the utility

meters.

The others arrested in the raids included Raymond Lam, 42 who also used the name "Nam A Lam", of Arcadia who is accused of being the overall leader of the drug trafficking organization and overseeing the acquisition of residences that were converted

Parking Restrictions Take Effect April 1

Walnut - Parking will not be allowed along Temple Avenue, the street that separates Cal Poly Pomona University and Mt. San Antonio College campuses. A safety issue was brought up by concerned Cal Poly students over a "Pizza With The President" event, according to the Cal Poly Pomona news release. Students asked what could be done to improve safety on Temple Avenue, which has been a major talk among students and residents. The intersection has a speed of 50 mph and there is no crosswalk beyond University Drive, making it a dangerous intersection for students who park on the south side of Temple. The road has two lanes in each direction separated by a raised median strip. The release reports that University officials began talking about ways to improve safety along this busy highway with

the Los Angeles County and City of Pomona which have jurisdiction over Temple Avenue. After this meeting, a study was conducted by the Los Angeles Department of public works analyzing traffic accidents, field observations and other related data. The results of the study showed 22 rear-end accidents combining both sides of Temple during a five year period ending last August. The reason for these accidents was because drivers stopped or slowed down mid-block to wait for a parking space. The suggestion by the Department of Public Works was to prohibit parking and stopping on both side of Temple Street between university Drive and Walnut City limit. The No-Parking, No-Stopping measure was approved on Feb 5 by the Los Angeles County board of Supervisors and will be enforced by local law enforcement agency. Beginning April 1, signs will be

installed affecting a reported number of 150-180 cars out of 22,000 daily visitors. In a weekly video message, University of Cal Poly Pomona President Michael Ortiz stated that the results were not what the University initially expected, and although suggestions for streetlights and increasing security patrol will not make a difference in accidents that happen in broad daylight, he respects the decision that was made by the County. The university President assured his students that administration officials are working hard to fulfill needs of the Campus and community without violating state and federal regulations. "The safety of the University has been in one of my highest priority," he added. With this new measure, University officials advise students and faculty to purchase parking permits or to find other alternatives such as public transportation. Community Club Treasurer Charged

Diamond Bar - A former Community Club treasurer was arrested and charged with grand theft and forgery this month. The charges stem from the misappropriation of funds from the Castle Rock Community Club, a non-profit organization created to raise funds and enhance opportunities for students attending Castle Rock Elementary School, according to an LA County Sheriff news release. Lisa May, also known as Lisa Haygood, was previously a volunteer as Castle Rock's Community Club treasurer. An investigation had determined that May took \$39,651 from the

Community Club's fund by forging checks numerous times. The release stated that the theft occurred over a 6 year period and was discovered in June of 2011. Since then, detectives have been sifting through a paper trail of bank records, checks and receipts which culminated in the case being presented to the D.A. for filing consideration. Detectives from Walnut/Dia-

mond Bar Station filed a felony complaint with the District Attorney charging May with six felony counts including Grand Theft and Forgery. A felony warrant was issued for May's arrest and she was taken into custody on May 5, 2013. May was also known as the AYSO Regional Commissioner. However, no reports of any missing money from AYSO have been reported.



Chino Pursuit Ends In One Death

Chino – On the early morning of Sat. Mar. 16, a 50-year-old man was killed by Police officials after a high-speed pursuit on multiple freeways. Ontario resident Jeffrey Langenhorst ended the pursuit in Eastvale, where he refused to step out of a tractor trailer when asked by San Bernardino County Sheriffs and Chino Police, which caused officers to open fire. Langenhorst was pronounced dead at the scene. The incident started when Chino Police Officers spotted an individual that matched the

description of a wanted fugitive by investigators. San Bernardino County Sheriff's spokesman Randy Naquin states that "after refusing to pull over for failure to yield, the officers began the pursuit." The pursuit lead officers through three freeways. The suspected fugitive also crashed into a patrol vehicle as well a civilian vehicle, and it was determined that he was driving in speeds up to 90 mph. Langenhorst exited the I-15 freeway and lost control of his vehicle in Eastvale. Langenhorst fled on foot and jumped into a tractor trailer, intending

to harm police officers. Naquin said that Langenhorst was warned to step out of the tractor and surrender peacefully; however, Langenhorst did not. When Langenhorst refused the officers request, the officers opened fired. Langenhorst was pronounced dead on the 4200 block of Hamner Avenue in Eastvale. According to Naquin, whether or not Langenhorst died instantly or not is still under investigation. On Mar. 17, it was released that Langenhorst was wanted on a federal arrest warrant. No further information has been released.

CH Homes Built Beyond Boundaries

Chino Hills – The City of Chino Hills has recently been under fire due to the encroachment notices it has been sending out these last few years, which caused a lawsuit and several city meetings regarding the issue. Encroachment is a term which implies "advance beyond proper limits," meaning the boundary lines for the city and homes. Each home is built within its own boundary area that contains a certain square footage limit between them and the cities protected open space. The protection of these open space areas has led to the rural atmosphere that resident's treasure, according to the city's website. Chino Hills has been handing out encroachment notices since early 2010, after recently switching to digitally recording its boundaries in 2008. This new system has allowed officials to see the exact boundary line and what houses are built over city property. Over 200 homes throughout the city have

been identified as building over city property and more are expected to be found. Most of the homes that have been identified have already handed in plans and drawings for their home improvements, resulting in a permit from the city prior to the digital recording of boundary lines. Many of the residents who have appeared at the City Council Meetings have voiced their concerns on the matter explaining that they have submitted the proper paperwork stating what they were to build, as well as plans and drawings for landscaping, and even obtained the proper permits by the city. Kim and Mike Denton, a family and residents of

Chino Hills, responded to the encroachment notices with a lawsuit. The Dentons had moved into their home in 1995 due to the lush and lavish backyard featuring palm trees, a pool, a spa, and a beautiful view of the hills that was left by the previous owner. However, their paradise became a nightmare when they were slapped with an encroachment notice from the city explaining to them that their backyard was encroaching upon city property and they must remove parts of it, including electricity, irrigation, fencing, and part of their pool. Further details on the lawsuit were unable to be obtained until the lawsuit finalizes.

Chase Bank Replacing Burger King

Diamond Bar - The Burger King off S. Diamond Bar Blvd. will soon be demolished to make room for a new Chase Bank branch.

The Burger King located in the Diamond Hills Plaza Shopping Center at 2717 S. Diamond Bar Blvd. was voted

to be demolished by the City's Planning Commission at the Tues. Feb 26 meeting with a 5-0 vote.

The Chase Bank branch plans to build a 3,431 square-foot bank with drive-thru ATM windows.

The commissioners were concerned about circulation for the drive-thru windows,

parking, and stop signs for pedestrian safety. However, they were ensured that any issues about circulation and signage for pedestrians in the drive-thru area could be addressed during the plan check, according to local reports.

A Diamond Bar city assistant planner said that the conditional use permit is to mitigate any

lighting, noise, circulation, or parking issues. The assistant also confirmed that the existing Burger King will be demolished and a new building constructed in its place, according to local reports.

Cal Poly Pomona Tuberculosis Scare

Pomona - About 375 students and staff members at Cal poly Pomona might have been exposed to tuberculosis by a student who may have tested positive for tuberculosis.

The Los Angeles Public Health Officials warned the University about the potential exposure. Cal Poly Pomona University sent out an email warning all students who may have had contact with the student about the possible tuberculosis spread early Friday morning.

The unidentified student who did not live on campus dropped

his winter courses to receive treatment. The student who was enrolled in the previous fall semester attended classes in physics, engineering, computer science, and women's studies.

"This is an unclear active case and the Los Angeles County Public Health has to do tests and update us on that," Justin Velasco Cal Poly Pomona Spokesman stated. "The student's prognosis so far is good," he added.

The student has not been identified and the date when he was admitted to the hospital was also not released due to privacy concerns. But

he admitted himself to the hospital Velasco said. It is not clear when or how the student became infected, but the university is encouraging students to contact the Cal Poly Pomona Student Health Services to schedule a visit.

Velasco stated that there are no other cases like this one or any outbreaks throughout the campus. Regarding the status of the student, Velasco said, "We have no updates so far."

As a result, the university is providing TB tests at no cost to all students. Faculty and staff can also receive testing through their regular health care provider.

According to the Los Angeles

Public Health website, TB is a bacterial infection that affects the lungs it can be cured with a prescription medicine; however, it can be fatal if left untreated. Common caused factors for this disease is overcrowded living conditions and malnutrition.

Common symptoms of tuberculosis are but are not limited to: bad coughing, sweating,

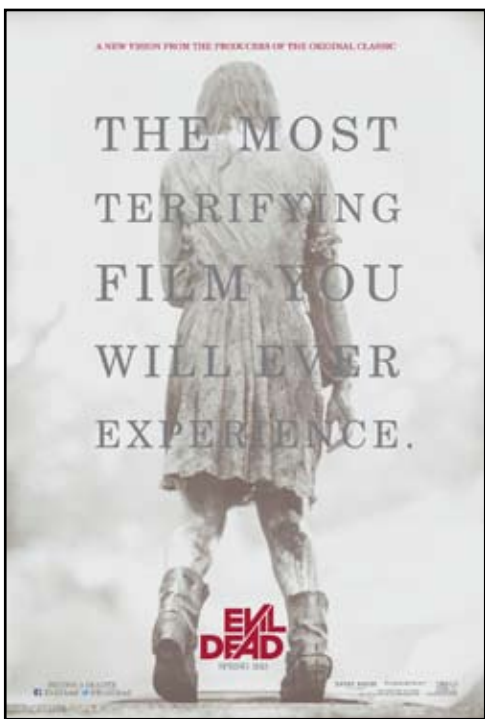
pain in the chest, weakness/fatigue, fever, chills. Check with your doctor if you suspect you may have TB symptoms.

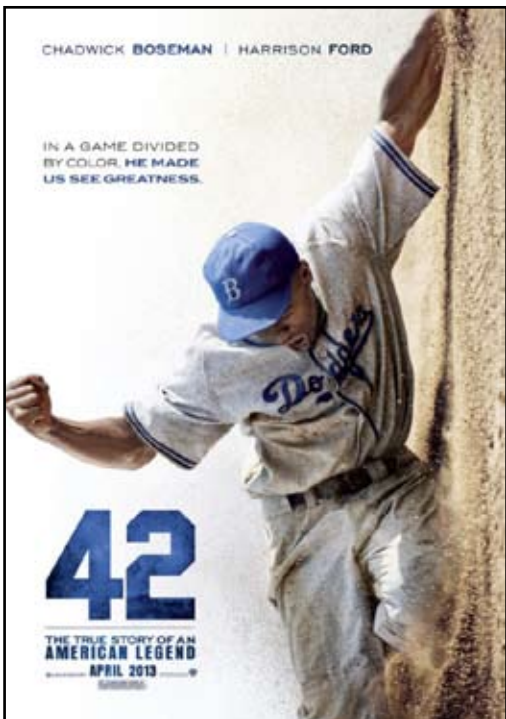

Diamond Bar Man Pleads Not Guilty

Diamond Bar – The CEO and co-owner of a Diamond Bar investment company pleaded guilty last week to two federal felony counts arising from his scheme to defraud investors who put \$49 million into his bogus day-trading venture.

Syed Qaisar Madad pleaded guilty to wire fraud and tax fraud, admitting in court last week that investors lost more than \$31 million when his scheme collapsed in March 2011.

Starting in 2005, Madad collected money from investors who believed he generated consistent, substantial profits, and that their money would

be safe and available upon request. During the 5½-year life of the scheme, Madad received more than \$49 million from investors.

Madad, 66, ran his scheme through a company called Technology for Telecommunication and Multimedia, Inc. portrayed himself as a successful investor who had not lost money in a single day of trading – except one day in 2006. Madad, who was profiled and interviewed in media serving the Pakistani-American community, told reporters and potential investors that he had developed a day-trading technique that was always profitable.

Over the course of the scheme, Madad sent victims

monthly account statements that always showed gains in their accounts, and some victims gave Madad additional funds based solely on these account statements. Madad admitted today that the balances shown on these statements were false, and that, in fact, he lost more than \$15 million in unsuccessful trading.

While Madad promised that he would not take any fees or compensation for managing the invested funds, Madad admitted today that he spent well over \$15 million of investors’ money on personal expenses, including real estate, jewelry for his wife and daughters,

vehicles and cash disbursements to himself and family members.

Although Madad returned approximately \$17.7 million to investors, many of the payments he made were Ponzi payments, meaning that the money came from funds entrusted to him by other investors, rather than from profits or interest he had earned.

Madad’s scheme originally came to light two years ago when he was sued by one of his investors.

Prior to and following Madad’s arrest in October 2012, pursuant to court-authorized warrants, the government seized a Mercedes-Benz, 68

pieces of jewelry, and other luxury items, including silk and wool handmade oriental carpets. Madad also agreed to pay the IRS approximately \$5 million in unpaid taxes for tax years 2006 through 2010.

Madad is scheduled to be sentenced by United States District Judge Percy Anderson on June 24. As a result of today’s guilty pleas, Madad faces a statutory maximum sentence of 23 years in federal prison.

The case against Madad is the result of an investigation by the Federal Bureau of Investigation and IRS - Criminal Investigation.

DB Band Teacher Pleads Guilty

Diamond Bar – A Diamond Bar man who is formally a local assistant band teacher, pleaded not guilty last week for charges of sexually assaulting a 16-year-old student.

Albert Anthony Morales, 33, appeared in Pomona Superior Court last week on charges of two counts of oral copulation of an unconscious person, two of sexual penetration by a foreign object, one of sodomy of an unconscious victim, and one of oral copulation of a person under the age of 18, according to local reports.

Detectives from the Sheriff’s Department Special Victims Bureau facilitated the arrest of Morales at his Diamond Bar home on Tues., Feb. 5, 2013,

according to a LA County Sheriff news release.

The incident allegedly took place on a former female student in the summer of 2006 when Morales was teaching at Sunny Hills High in Fullerton.

Morales has been tutoring band students, specifically as a percussion instructor, for the past 13 years and has taught or volunteered in the Los Angeles and Orange County areas. Morales most recently taught at Diamond Ranch High School and has previously worked at Diamond Bar High, authorities said.

More victims are being sought by the Special Victims Bureau when Morales worked at Diamond Bar High from 1998 to 2000, Sunny Hills High from 2004 to 2009, and Diamond Ranch High from 2012 to

2013.

Fountain Valley, is charged with one felony count of vehicular manslaughter while intoxicated and one misdemeanor count of driving on a suspended license. If convicted, he faces a maximum sentence of four years in state prison. The People will

be requesting Morales be held on \$100,000 bail at his arraignment at the West Justice Center in Westminster. At approximately 7:15 a.m. on Oct. 1, 2012, Morales is accused of driving in an industrial area in Fountain Valley to work as an automobile mechanic in a truck belonging to a customer. The defendant is accused of being under the influence of metham-

phetamine. Victim Timothy Michaud, 49, was working underneath an RV, which was parked on the side of the road and elevated on blocks. Due to its size, the RV was protruding slightly into the road. Morales is accused of failing to avoid the RV and crashing into it, causing it to fall onto the victim. Morales remained at the scene and at-

tempted with other witnesses to free the victim using a hydraulic jack, but the victim was crushed by the RV and died at the scene. The Fountain Valley Police Department responded to the scene and investigated this case. The defendant's blood

was examined by the Orange County Crime Laboratory. At the time of the crime, Morales is accused of being under the influence of a high quantity of methamphetamine. Senior Deputy District Attorney Troy Pino of the Homicide Unit is prosecuting this case.

into full scale, industrial-type grow houses which included 1000-2000 plants per house, as well as the lieutenants of the operation. The lieutenants included Simon Lam, 32 of Arcadia; Ken Ho also known as "Ken Lam", 33 of Arcadia; San S. Voong, also known as Chen Sheng Wang, 35 of Arcadia; Phieu Tran, 35 of El Monte; Augustine Bazan Camacho, 41 of Pomona who was allegedly a veteran "plant tender" who was responsible for maintain-

ing many of the grow houses; Thanh Van Phu, 33 of El Monte; Luc Kai Phoung, also known as "Wong Fong," "Al Fong " and "Na Na," 50, of Rosemead, who allegedly built the electrical and utility meter by-pass systems used at the grow houses; and Li Ya Si, 42, of Temple City. During the raids, authorities seized more than \$250k in cash, 7 guns including an assault rifle, and more than 8k marijuana plants. All of the arrested defendants are being charged with conspiracy to manufacture, distribute, and to possess with intent to distribute marijuana, according to the U.S.

District Court in Riverside. If convicted, the defendants could face 10 years to life.

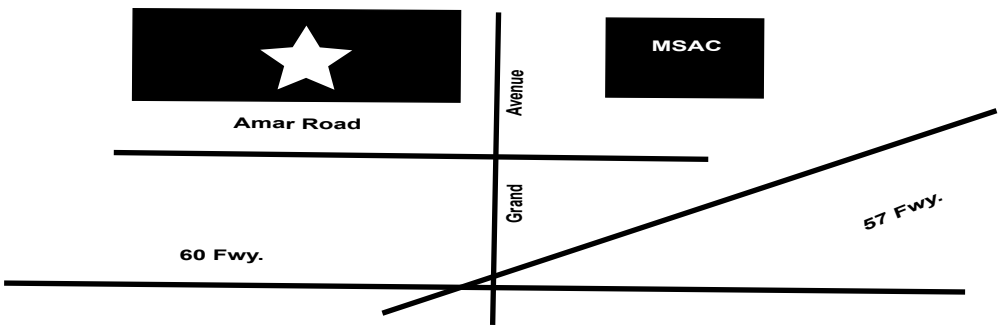
