Board Votes

SAN BERNARDINO COUNTY RELEASE

San Bernardino – The County will continue to fight the state's efforts to grab \$9 million set aside to rebuild fire-ravaged Cedar Glen. The Board of Supervisors today voted unanimously to appeal a May 27 Sacramento Superior Court ruling that would allow the state to disperse \$9 million the county had loaned to the Cedar Glen rebuilding effort.

"That loan was a promise by the county to the people of Cedar Glen," said Board of Supervisors Chair Janice

Pacheco Selected To Walnut City Council

Walnut – At the Walnut City Council meeting on Wednesday night, the Council selected a familiar face to fill the vacant seat: former state Assemblyman Robert "Bob" Pacheco. The Council nominated Pacheco and then voted 3-0-1, with Councilman Eric Ching abstaining.

Before running for state office,

Pacheco served on the Walnut City Council in the 1990s for two years. Pacheco has been involved in the community for many years and that was one of the reasons why the council members were drawn to selecting him. In addition, Pacheco's political experience and con-

Deputies Honored By DB City Council

Diamond Bar – The Diamond Bar City Council recognized three Los Angeles County Sheriff's deputies last month for capturing a suspect that was wanted for local gas station robberies.

Deputies Danta Moore, Franklin Novelo, and Ray Huang were recognized for their efforts in arresting Edward Anthony Sanders outside the Arco AM/PM gas station at Brea Canyon Road and Lycoming St., just seconds after he committed a robbery.

Saunders, 31, was taken

into custody on June 23 and is believed to have committed at least three armed robberies within four days at gas stations in Diamond Bar and Walnut, according to the LA County

Two Year Closure For Nogales Street

City of Industry – According to the Alameda Corridor-East Construction Authority (ACE), construction has begun on the Nogales Street Grade Separation and Road Widening Project in the City of Industry and unincorporated areas of Rowland Heights. Once completed, the project will provide a train bridge over Nogales Street, and under-

pass for vehicular traffic and the widening of Gale Avenue and Walnut Drive North.

The goal of the project is to alleviate traffic congestion in that area and eliminate possible vehicle collisions with trains at the current crossing.

Although major construction began this past May, a Construction Alert from ACE says that Nogales Street is expected to be closed in the summer of 2014 for

approximately two years. Prior to that, a detour route with a temporary railway crossing will be completed to connect local north/south traffic with Nogales Street.

The first year of construction will provide street widening for Gale Avenue and Walnut Drive North, the underground utility

24 Maternity Hotels Cited In LA County

La County – Twenty-four confirmed Maternity Hotels were cited in Los Angeles County, but overall, new complaints from the public about suspected birthing centers have decreased significantly, according to a new quarterly report released last week by the Chief Executive Office of Los Angeles County.

In total, the multi-agency taskforce, consisting of various County departments including Regional Planning and Sheriff's, as well as Mandarin and Cantonese translators, has inspected 82 locations throughout the County and was able to gain access to 70 properties suspected of operating maternity hotels. Numerous violations were found at these locations including unsafe health

conditions, unpermitted room conversions, and properties operating as boarding homes without proper licensing. In the last three months, only three new complaints about suspected maternity hotels were logged.

"The inspections conducted by the taskforce have proven to



City Council Commends City Employee For Heroic Deed

Walnut — During the July 24, 2013 Walnut Council Meeting, the City Council presented numerous certificates and commendations to City of Walnut Recreation Leader, Larry Gordon, for properly using an automated external defibrillator (AED) to revive an unconscious patron at the Walnut Gymna-

sium/Teen Center.

During his shift on the night of July 12, 2013, Larry noticed a patron collapse on the basketball court and it was quickly determined that the patron was in cardiac arrest. 9-1-1 was called while Larry grabbed the facility AED, and a bystander began CPR on the patron. Larry then applied the AED to the patron and administered a shock, reviving

the patron. L.A. County Fire Department Engine 146 and Squad 61 were dispatched to an unconscious patient on the basketball court at the Walnut Gym/Teen Center. When emergency personnel arrived, the patron was conscious and sitting-up. Emergency personnel transported the patron to Pomona Valley Hospital where he was discharged from three days later.

Emergency personnel commented that if not for the quick actions of Larry and the bystander prior to the arrival of the fire department, the patron would not have survived his cardiac arrest.

Mayor Antonio "Tony" Cartagena said, "I am proud that Larry is part of the Walnut family, and his heroic deed shows how important CPR/AED and first aid training is for all of us."

Larry received a commendation from the City Council as well as certificates from Senator Bob Huff, Assemblyman Curt Hagman, and Supervisor Gloria Molina's office.



Sheriff's Department.

After Saunders robbed a gas station at the AM/PM off Brea Canyon Rd. and Diamond Bar Blvd., Captain Jeff Scroggin said that they were able to get a great surveillance photo of Saunders. Deputies Moore, Novelo, and Huang then went around the area showing the picture to local businesses and gas stations.

On the night before Saunders was arrested, Deputy Moore went to the Arco Station and showed the clerk a surveillance photo of Sanders. A news release reported that Moore told him to be on the lookout for Sanders because he had committed other robberies in the area. Within two hours, the clerk saw Sanders in the parking lot and he appeared to be milling around, waiting for the customers in the store to leave. The clerk immediately called the Walnut Station to report seeing him. Moments after hanging up, Sanders walked in and robbed the clerk with a

handgun.

As he was walking out through the parking lot with an undetermined amount of cash, the deputies arrived and arrested him.

Evidence of other crimes was found in Sanders' car, which he had parked across the street in another parking lot. The Deputies checked with other police agencies and Scroggin said that Sanders is believed to have committed a total of 11 robberies. The semi-automatic handgun Sanders used in his robberies had been stolen in a residential burglary, according to the LA County Sheriff's Department.

Capt. Scroggin told the members of the Council that these deputies usually work the graveyard shift and he appreciates them for patrolling the streets

while everyone is sleeping in order to keep the community safe.

"I'm very proud of my graveyard shift team," said Scroggin at the City Council meeting. "These guys are awesome and did a great job," he added.

Mayor Jeff Tanaka presented the certificates to the deputies on behalf of the Diamond Bar City Council and Diamond Bar community. "We applaud your work ethic and thank you for your exemplary services to the Diamond Bar community," said Tanaka.

Sanders appeared in Pomona Superior Court on July 15, where he pleaded not guilty to all of the charges. He faces one count of kidnapping to commit another crime, three counts of second degree robbery, three counts of possession of a firearm by

a felon, one count of carrying a loaded stolen firearm, and one count of receiving stolen property, according to the LA County District Attorney's office.

Sanders is being held on \$1 million bail and his next court date is Aug. 7.

Congratulations on your engagement.



be a successful deterrent to new maternity hotels setting up in our neighborhoods and communities," said Supervisor Don Knabe, whose motion created the task-force and called for an ordinance to regulate maternity hotels in Los Angeles County.

A proposed ordinance to regulate maternity hotels was not recommended at this time because the Department of Regional Planning is still conducting inspections. The Department can still issue notices of violation where maternity hotels are operating illegally because under current County codes, boarding houses are not allowed in a single-family residential zones with more than five persons

unrelated to the operator.

convicted on all counts, Canady faces a maximum sentence of 15 years and four months in state prison. Canady is being held in custody on \$75,000 bail and is scheduled for a pre-trial hearing on Aug. 6, 2013 at the North Justice Center, Fullerton.

Canady is accused of being a pimp/human trafficker who exploits women and children for financial gain. The victims are required to turn over all payment they receive for sex acts from sex purchasers to their pimp.

Prior to July 25, 2013, the defendant is accused of driving 19-year-old Jane Doe #1, 16-year-old Jane Doe #2, and 15-year-old Jane Doe #3 to an area known for commercial sex on Beach Boulevard in Anaheim.

The defendant is accused of dropping off the victims and instructing them to engage in acts of commercial sex. Undercover officers of the Anaheim Police Department (APD) observed two

\$9 million could make a real difference in Cedar Glen, and the county will fight to keep its promise."

When the state abolished redevelopment agencies throughout the state in order to redistribute their funding to various state and local government agencies,



nections to state and federal legislators were also reasons why the council members considered him.

Ten candidates applied for the Council appointment to fill the vacant seat due to the resignation of Councilmember Tom King. Each candidate gave an oral presentation and told the Council about their qualifications and goals if they were picked to be a member of the Council. They also answered the council members' questions regarding a variety of topics in Walnut.

After talking with the candidates during the almost three hour meeting, the Council tried to decide how they were going to pick the applicant that they thought was the most qualified. Councilman Eric Ching made two suggestions regarding the voting process, but both failed to get support. City Attorney Michael Montgomery also made a suggestion to use their automated green light buttons, but the council members didn't support that as well. Then, Mayor Antonio "Tony" Cartagena suggested to keep the tradition of someone nominating a candidate and voting afterwards.

First, Ching nominated Dr. Howard Wang, who ran for council in 2010, but that motion failed. Ching then nominated James Swartz, who serves on the Parks

and Recreation Commission, but that motion failed as well.

Then, Councilwoman Mary Su nominated Pacheco. She talked about his community involvement and pointed out that he can bring a lot of state and federal resources to Walnut.

Cartagena also spoke in support of Pacheco before the Council took the vote. Cartagena agreed that his community involvement and political expertise

make him a good candidate. He also talked about how Pacheco has already contributed to the City of Walnut and has proven himself in previous actions.

Pacheco was sworn in to office by his wife, Gayle Pacheco. Pacheco's term ends in April 2014, but he still plans to run for the seat when his term is over.

After he was sworn in, he talked about the other nine candidates' talent, heart, and love for

the city and he suggested getting together with the applicants to form an advisory committee.

He also talked about the City's budget and how he feels he can

help get the City some money that the state owes Walnut in the form of intergovernmental transfers, according to local reports.


