## Beware Of Door-To-Door Scams

**Diamond Bar** – It starts with a knock at the door or ring of the doorbell. On the other side is a young person claiming to be selling magazine subscriptions in order to raise money for a school trip or other "worthy" cause. You place and wait for your order, but

your magazines never arrive.

Scams involving deceptive door-to-door salespeople are among the most common complaints received by the Better Business Bureau (BBB), which is why taking the following steps is strongly encouraged:

• Before making a front porch purchase, ask the salesperson

to see a valid City business license – all individuals and businesses doing work within city limits, whether or not they have a physical structure in the city, are required to have a business license.

## Remembering To See The Beauty

At the end of July, I went on a Missions Trip to Haiti with about 12 people from my church and from other churches. This was the first time I had ever been out of the country and had ever been on a Missions Trip, and I decided to make it count by going to a 3rd World Country.

If someone mentions Haiti, some think of the earthquake that happened in 2010, some think of poverty, some think of diseases and some think of the corrupted government. Even though all of this is true about Haiti, now that I have been there, these aspects are not the first things that come to my mind. When I think of Haiti, I think of the beautiful mountains that surround the villages. I think of the clear blue water of the Caribbean Sea that some of my teammates were fortunate enough to get baptized in. I think of the fields of crops that the Haitians grew themselves in order to survive. I think of the Haitian people in the villages waving at us and saying "Bonswa" (meaning hello in Creole) as you walk through the villages. I think of the children who ran after our car just to get a glimpse of an American, as if we were famous.

When I think of Haiti, I can't help but to think of the beauty of the country, mainly because of how welcoming the people are. We were strangers to these people and they didn't know what we were doing there or what we were even saying, but they welcomed us into their homes, they let us hold their children, they let us pray with them, they smiled at us as we walked by, and they said hi to us as if we were a part of their everyday lives. Even the Haitians (both children and adults) who could speak a little bit of English would try so hard to just have a simple "Hi, how are you?" or "What's your name?" conversation with us...those small talk conversations we all dread in the United States.

You see, Haiti IS filled with poverty. It is filled with houses that are made of tree branches and tarps. It is filled with people who barely have food, clothes, and water. It is filled with people who shower once a week in a river in the middle of the day. It is filled with people who walk miles just to get a jug of water for their families. It is filled with people who rely on the sun to know what

time it is or when it's time to go to sleep, because they don't have electricity. And it is filled with thousands of children who don't have parents or families.

Knowing this, the first thing that probably comes to our minds is: how sad. How sad it is to live in this kind of environment. How sad it must be to have a child run up to you and hold your hand as you are walking through the village, just because they normally don't get that affection. How sad that children are running around without clothes or diapers on, because their parents can't afford it. How sad that some of the people survive on a meal of rice once a day. How sad.

But you see, despite all this, I think the real statement is how sad we are. How sad it is that we have so much in our lives, have so much food, shelter, clothes, family, water... and we take it all for granted. We waste it. And worse, we strive for more.

The Haitians are the complete opposite. They are praising God every second of every day for the little they have. They are appreciating every second of life and every scrap of food they can provide for themselves and for their families. They even appreciate something as simple as a picture we printed out for them, because they had never even seen their own face, let alone have ever had a picture of themselves.

There are so many little things we take advantage of because we tend to forget how fortunate we really are. So my challenge to you is to start noticing the beauty in your lives, and to appreciate everything you have. Start appreciating your family, friends, food, water, electricity, clothes, jobs, and for the amazing country we live in. Because as one of my teammates brought to our attention in Haiti: we didn't earn this lifestyle. Almost all of us didn't work hard to be here in America. We were just born into a fortunate country, while others around the world were born into poverty. There was no difference or special task we did to be here. But as our leader said, with that great fortune is a responsibility. We have a responsibility to appreciate every little thing we have, and a responsibility to help the ones that don't have much.

As much as I want to tell you to take a trip to another country to help others, I know that not every-

one can just get up and go. But there are so many ways you can help from afar. Our team is still trying to help the Haitians from afar by collecting clothes, shoes, diapers, etc. and sending it out to Haiti for the people who need it. I hope you will take the challenge to start appreciating the wonderful country we are fortunate to live in. I hope you will take the time to tell your loved ones how much you are thankful to have them. I hope you will stop striving for more, and start giving more instead. And I hope



you will always remember to see the beauty in everything.

# 2,313 Arrested During DUI Campaign

## LA COUNTY SHERIFF

**LA County** - The 2013 Summer/Labor Day Holiday DUI Mobilization crackdown on drunk and drugged drivers has ended and resulted in a significant number of DUI arrests from the sobriety checkpoints, special

saturation patrols and routine patrols in Los Angeles County for the past 18 days.

From 12:01 a.m. Fri., Aug. 16, through midnight Mon., Sept. 2, 2013 officers representing 100 county law enforcement agencies have arrested 2,313 individuals for driving under the

influence of alcohol or drugs. In 2012, 2,098 DUI arrests occurred during the same time period.

Two individuals have been arrested on felony DUI charges causing death. Reports are still out on additional fatal crashes that occurred during the cam-

paign period pending coroner's information.

All numbers are provisional with some agencies yet to report. Law enforcement officials will be conducting more Avoid anti DUI efforts throughout the county and region again during Halloween and Thanksgiving before planning for the December Winter Campaign periods.

Police, Sheriff and the CHP encourage all motorists to help make your community safer: Report Drunk Drivers - Call 911! anytime you encounter a dangerous impaired driver.





On Sept. 3, a man was charged with the murder of his mother. The woman, who was identified as Vilma Chau, 63, was the mother of the suspect who was identified as Clifton Huang, 43. Officers first discovered the body of the victim when they went to investigate a complaint made by a family

member. The family member stated they had not heard from the suspect in a while and they noticed a strong odor emanating from the garage. When officers searched the house, they found the body of the woman bound by her hands and feet in the trunk of her Mercedes Benz. Huang, who was home at the time, was then booked on suspicion of murder.

Huang's criminal complaint also shows that he has five prior felony convictions between 2003 and 2011 for offenses including unlawful driving or taking of a vehicle, possession of a controlled substance and dissuading a witness from reporting a crime. Huang will be arraigned on Sept. 24 at the Pomona Superior Court.

- Do not feel pressured to make a hasty decision to purchase; instead tell the seller to give you time to think it over, and research the company or charity with the Better Business Bureau – [www.bbb.org](http://www.bbb.org). If you own a smart device, downloading the free BBB app is a fast and a convenient way to access a company's report.

• If the company proves to

be legitimate and you decide to proceed with the purchase, be certain to get transaction details in writing. In addition to a contract or receipt, the salesperson is legally required to tell you about your cancellation rights and provide you with two copies of a cancellation form. Remember, the Federal Trade Commission's (FTC's) Cooling-Off Rule allows you to cancel certain purchases made from home valued at \$25 or more; to obtain a full refund you must do

this before midnight of the third business day after the sale.

If you have been a victim of fraudulent door-to-door sales, you may report the scam to the Diamond Bar-Walnut Sheriff's Station at 909.595.2264 and the Better Business Bureau at [www.bbb.org](http://www.bbb.org). Complaints related to FTC's Cooling-Off Rule or other consumer matters may be filed online [www.ftccomplaintassistant.gov](http://www.ftccomplaintassistant.gov) or by phone 877.FTC.HELP (382.4357).

nounced the mother dead at the scene, and rushed the father to a local hospital. He is expected to survive, and will be questioned pending recovery.

Detectives are calling this a crime of domestic violence, and they believe the husband killed his wife, and then attempted to take his own life. The names of the couple, both in their 50s, have not yet been released.

Regina Wilks, a neighbor of the couple on Wells Spring Street, said she just saw the man mowing his lawn this past weekend. She had purchased a car from the couple the previous year, and said they were really nice people.

This is an unusual situation for the quiet

community of Eastvale, where the low crime rate makes local citizens feel safe. But according to the National Coalition Against Domestic Violence, this type of situation affects individuals in every community, regardless of age, economic status, race, religion, nationality or education.

In fact, 85% of domestic violence victims are women, and one in four women will experience it in their lifetime – most of the time by someone they know. An estimated 1.3 million women are victims of physical assault by an intimate partner each year; however, most cases are never reported to the police.



# Homeless man convicted

residential burglary, one felony count each of assault with intent to commit a sexual offense during a residential burglary, lewd act upon a child under 14 years old, attempted kidnapping to commit a sexual offense, attempted kidnapping for child molesting and attempted residential burglary. The sentencing allegations and enhancements for having a non-accomplice

present during three residential burglaries and committing a lewd act during the commission of a burglary were found true.

On Aug. 21, 2013, the defendant pleaded guilty to two counts of residential burglary in this case. Aguirre faces a maximum sentence of life in state prison and mandatory lifetime sex offender registration at his sentencing Nov. 8, 2013, at 9 a.m. at the Central Justice Center in Santa Ana.

At approximately 2 a.m. on

June 22, 2010, Aguirre entered a locked and occupied home and stole property from the downstairs living area. He went upstairs to search for more property to steal and encountered 10-year-old Jane Doe. The defendant approached the victim and used a razor blade to cut her shorts from the waist down and told her to leave the upstairs living room with him approximately four times, with the intent to sexually assault her. Jane Doe began to cry and Aguirre fled the upstairs living area and exited through the front door. He left his

fingerprints in the house.

During the early morning hours on June 25, 2010, and June 26, 2010, Aguirre entered two locked and occupied homes and took the victims' wallets, purses, cell phones, and other property. Aguirre left his fingerprints inside the homes.

At approximately 2 a.m. on June 28, 2010, Aguirre attempted to break into a home. The victim called 911 and Aguirre hid in the bushes next to the residence. Buena Park Police Department (BPPD) arrived and located Aguirre and arrested him

at the scene.

Aguirre's mandatory lifetime sex offender registration will bar him from entering County recreational areas and City parks which have passed the Sex Offender Ordinance. BPPD investigated this case. Deputy District Attorney Nancy Hayashida of the Sexual Assault Unit is prosecuting this case.
