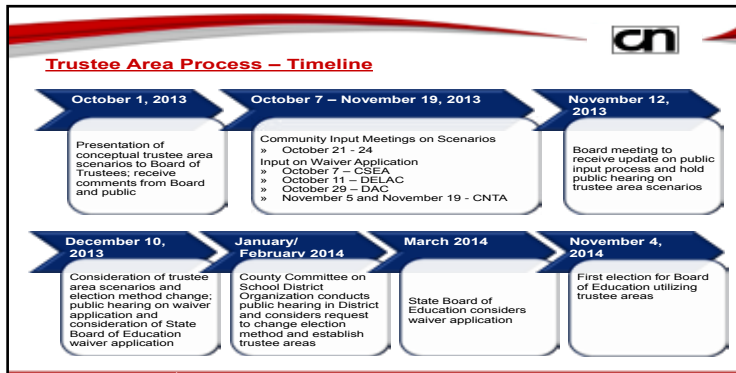

## Norco's Silverlakes Project - What Happened?

**Norco** - Silverlakes Equestrian Sports Park, the anticipated 122-acre recreational facility that began its development as far back as 2007, has been at a standstill for some time. Developer R.J. Brandes

of Balboa Management Group, vowed the project's completion as recently as July of this year, telling City Council that delays from property flooding, a lack of funding, and a personal divorce were at the root of the problems. He said funding was imminent the next week, and the project

would be completed in nine months. The barren acreage at Hamner and Citrus Avenues does not excite one to expect a grand opening this spring.

## Eastvale Fights For Vehicle License Fees

**Eastvale** - Eastvale city officials have decided to continue pursuing the funds from Senate Bill 56 (SB56) which will attempt to collect funds lost when lawmakers decided to divert vehicle license revenue to lo-

cal law enforcement grants. As a result, Eastvale has lost roughly \$8 to \$9 million since the decision was made in 2011. This affects not only our city, but the cities of Jurupa Valley, Wildomar and Menifee, who all were expecting that money as part of their operating budgets. The four cities had

been working together with a lobbyist in Sacramento to get the funds reinstated, but were unsuccessful in past budget years.

With lawmakers recessing

# What is the Municipal Code and What Does it Do?

The City's Municipal Code can be described as the operating manual for the City. It encompasses all aspects of City regulations, including zoning and various development related requirements. In addition, the Municipal Code provides zoning standards for development

and architectural review, parking, signs, home occupations, variances and other similar topics are included. Aside from zoning standards, other City regulations are also contained within the Municipal Code, such as subdivision requirements, business license regulations, street, water and sewer standards, animal control, public morals and safety as well as vehicle and traffic requirements. The Eastvale Municipal constitutes a codification of the general and permanent ordinances of the City of Eastvale, California. It is a published compilation of City laws and their revisions organized in

Title-Chapter format. When the City of Eastvale incorporated in 2010, we automatically adopted the Riverside County Municipal Codes under which the community had previously been operating. Many of the county's Municipal Codes were not applicable or consistent with the lifestyle of Eastvale since they had been designed to meet the needs of Riverside County as a whole which covered a much larger, more diverse area. After months of review by the Eastvale City Attorney and City Clerk, a revised and more suitable Municipal Code was adopted for the City of Eastvale in February 2011.

This current Municipal Code is what the City's very busy Code Enforcement Department cites when issuing correction notices or citations. The Municipal Code is updated periodically as new ordinances are adopted by the City Council such as the Scavenging Ordinance, Social Host Ordinance and more. Residents can also review the NEW Eastvale Community Neighborhood Preservation Standards brochure which outlines some of the most frequent

## Did You Know???

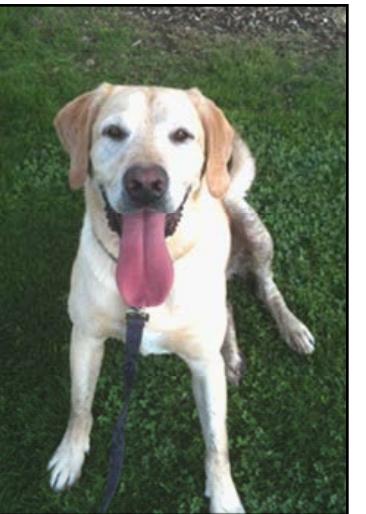

Did you know that the City Municipal Code Sec. 18.08.020 (a)(b) – Mandatory Dog Licensing and Vaccination states that (a) it is unlawful for any person to own, harbor or keep any dog, four months of age or older, within the city, for a period longer than 30 days, unless a currently valid license tag has been issued by the director or any agency authorized by the city. The Code further states: (b) It is unlawful for any person

to own, harbor or keep any dog, four months of age or older, within the city, for a period longer than 30 days, which has not been vaccinated against rabies. Every person in the city who owns, harbors or keeps any dog over four months of age for a period longer than 30 days shall have such dog vaccinated against rabies as provided in this chapter, by a veterinarian of his choice and such vaccination shall be renewed in accordance with the applicable laws and regulations

of the state. Animal Control Officers have been conducting random licensing checks throughout the City of Eastvale and have determined that approximately every 2.8 houses in Eastvale have an unlicensed dog. The licensing of dogs is required by State law and City Ordinance. Licensing your dog is easy! Take advantage of one of these three simple options to make the purchase or renewal of your pet license(s) convenient. You can buy or renew your pet li-

cense online at [www.rcdas.org](http://www.rcdas.org), mail in your license application (forms available at [www.rcdas.org](http://www.rcdas.org)) or visit our local shelter located at 6851 Van Buren Blvd, Riverside CA 92509. The rabies vaccine, which must be current is the only vaccination required for licensing. ## Eastvale Town Hall Meeting Recap

**City Update: Presented by Mayor Ike Bootsma**  
Eastvale – Mayor Bootsma discussed some of the upcoming residential developments coming to Eastvale, including 40 acres of master-planned community, including 350 cluster homes. D.R. Horton has two residential developments: The Trails at Eastvale, Archibald Avenue and 65th Street, with 224 homes; and The Palms at Eastvale, Citrus Avenue across from Roosevelt High School, an upscale community with 197 homes. Bootsma also shared that Eastvale was pleased to be named the “13th Most Diverse City” and the highest median income city in Riverside County. Some of the new businesses that were recently welcomed to Eastvale are The Habit Burger Grill, and Massage Envy. San Antonio Community Hospital will be opening a Medical Center near 24-Hour Fitness as well. Mayor Bootsma reminded us to “Shop Eastvale”, as the City benefits from local sales tax. Questions from the community were also answered by Bootsma and City Manager, Carol Jacobs, about how the city addresses traffic and busy intersections. Traffic is monitored and controlled by the Eastvale Police, radar, timing of lights, etc. Developers widen roads and make improvements as they develop properties as part of their construction costs. There are some additional roads that will be widened, including a

portion of the Mayor's yard near the channel bridge located next to his property in the next six to eight months.  
**Riverside County 2nd District Update: Presented by John Field**  
Two major issues facing our county presently are the jails and the county hospitals. We have had a \$200 million per year drop in County discretionary revenue. Assembly Bill 109 (AB109) passed, and that requires the counties to now be responsible for inmates instead of the state. This has triggered a scrambling for funds in order to pay for beds in jails. It has also made it necessary to release 7,000 prisoners early in 2013, with an expected 9,000 to be released early in 2014. The county did receive a grant which allowed them to add 1,200 beds and they are hoping to receive another grant for more beds. One solution to this problem could be moving inmates from public institutions to private institutions at a cost of \$68 per day vs. \$140 per day. County Hospitals have also been hit hard, losing \$10 million dollars last year, as they are required to treat anyone and everyone regardless of their ability to pay. Often they are not reimbursed or if they are, only at 50% of actual costs. Hospital Administration is currently getting ready for the implementation of the Affordable Care Act  
The 91 Freeway widening construction, from the Orange County border line up through Riverside, will begin in January. This is estimated to be a four-

year project and will affect private property and businesses along the way.  
UCR Medical School opened with its first class of 50 students, making it the first new California Medical School in 40 years. With the dire need for medical professionals in Riverside County, this is very exciting news for our area as it will help boost the economy. Eventually the Medical School will have more students, 80 per class, for a five year program. Students who graduate, complete their residency and practice medicine in Riverside County for five years will have their Medical School paid for.  
**State Senator's Office: Presented by Violeta Aguilar-Wyrick, on behalf of the Senator unable to attend)**  
The Legislature closed last month. Senator Roth's office is still working on trying to get the funds back from the Vehicle Licensing Funds that were diverted, causing Eastvale and three other new cities to lose crucial money (please read full story on Page 1 for more details).  
**Corona-Norco School District (CNUSD): Presented by Bill Newberry and Ted Rozzi**  
Common Core workshops continue to be given to help parents become informed about changes to the curriculum. Rozzi stated that, “This is a huge paradigm shift in education and it's very important that everyone understands it”. Yorba School will also begin construction on the Elementary School located on Fieldmaster

Street in Eastvale. Phase I is expected to be completed in April/May of 2014 (please read the full story on page 12 for more details).  
**JCSD: Presented by Richard Welch, Director of Parks and Community Affairs**  
Ric Welch, Parks Director, shared that the Eastvale Community Park is almost complete, with hydro-seeding just finishing up. Once the turf is established, the park should be opening near the end of the year. There will be an opening celebration with official usage of the park expected in January. There has been some wild pig damage to Riverwalk Park and JCSD is working with Fish and Game and hunters to remedy the problem. Resurfacing of tennis courts and replanting of some plants and grass is also happening throughout the City. The very popular Tiny Tots Program will be getting an additional location and opening 24 new spots. The Holiday Tree Lighting Event will be at The Eastvale Community Center on Saturday, December 7, from 3:00 p.m. to 9:00 p.m.  
**Eastvale Community Foundation: Presented by Sharyn Link, Executive Director**  
Sharyn Link shared that they were approved for a grant fund that will allow them to help provide more scholarships for the arts, sports, etc. Applications will be available shortly. The foundation also donated money to the Military Banner Program, with 10% of every event they have going to the fund. The recent golf tour-

namment was a success, with profits of \$21,000.  
**Riverside County Sheriff and Cal Fire: Presented by Lieutenant Michael Yates and Jackie Williams**  
Assistant Chief of Police Lieutenant Michael Yates gave a crime update explaining that due to AB109, there were 7,000 inmates released early last year; 14 have been released in Eastvale and we know where they are, and they are patrolled. He also presented statistics for crimes and response times and reminded residents to make sure to remove valuables from your vehicles. Vehicle and residential burglaries are highest between 8:00 a.m. and 4:00 p.m., Tuesday through Friday.  
**Jackie Williams from Cal Fire** presented some statistics about responses times and reasons for calls. 70.2% of all calls were for medical emergencies. The new Fire Station on Selby Avenue and Chandler Street is currently in escrow and is expected to close near the end of December. Specs for the site are being discussed. There are now five people at the current station, with a new medic squad (and additional paramedic) that went into service on October 14. They have already responded to 73 emergency calls. We have also added a new Fire Safety Specialist, Jason Walsh.

# City council recap

## RECAP from page 1

Welch absent.

The following items were passed with a 3-0 vote: September 17 Special Council Meeting Minutes, September 25 City Council Meeting Minutes, the Proclamation-Freedom From Workplace Bullies Week, the Business Registration Certification Program, 5.6 Solid Waste Collection and Disposal Ordinance, 5.7 Delegation of Authority to the City Manager on His/Her Designee to Execute Right of Way Certifications, 5.8 Resolution of Intent to Vacate a Portion of Schleisman Road, and 5.9 Acceptance of Easement Dedication for Right of Way Purposes - John C. Leal and Elizabeth Leal Trust.

Item 5.5 was pulled from the calendar until the October 23 meeting, which is the Single-Family Residential Rental Registration Inspection and Crime-Free Rental Housing Program.

Council Member DeGrandpre clarified any confusion regarding his vote at the September 25 Council Meeting, saying his objection to the new marijuana ordinance is he feels it does not go far enough and there are no real "teeth" to the ordinance. He also said that the only people who will open their doors willingly to an inspection are those who have nothing to hide. He also spoke of other cities that have adopted a similar ordinance and said he has contacted City Managers and/or City Attorneys for these cities: San Bernardino, Sacramento, Santa Cruz, and Richmond. DeGrandpre went on to say that people doing illegal activities will simply not allow the inspections. But he feels that homeowners should be held accountable if illegal activity is occurring in a rental property. He said the ordinance should apply to everyone and that maybe there should be a possible fine along with court costs, which would

make a homeowner more likely to inspect their own property.

Council Member Rush moved a motion to bring back the ordinance at the next meeting, when the rest of the council is present. Council Member Howell seconded that motion.

The following new business items were passed with a 3-0 vote: 8.1 Account Application/Client Agreement, Authorizing Persons and Enabling Resolution/Morgan Stanley, 8.2 Implementation and Task Force Agreements (Riverside County Storm Water Program), and 8.3 Renewal of Contract With Riverside County Fire Department for Fire Protection Services, in the amount of \$2,688,037.77, for Fiscal Year 2013-14.

Also stated was the Annual Contract with County Fire for Protection Services: included this year are one additional paramedic unit and a new Fire Protection Specialist. The Paramedic Unit was expected to go into service on October 14.

In the Council Communications section of the meeting, Councilmember Rush said there is a lot of interest in the Sign Ordinance program. He requested staff to begin the process of presenting the Sign Ordinance to the Planning Commission for review, and then to Council for approval.

Following the Council Communications was the City Manager's Report, read by Carol Jacobs. Jacobs gave an update on the meeting at Eastvale Elementary School on October 3 regarding the construction on Schleisman Avenue and Scholar Way. She said that 60 people attended the meeting, including the Mayor, and there were presentations by George Alvarez and D.R. Horton personnel. Jacobs also said that D.R. Horton agreed to pay for two additional police officers to manage traffic in and around the schools, two hours in the morning and two hours in the evening, at a cost of \$9,000. She also said that D.R. Horton has been above standards, and they have gone the extra mile

for the City.

Jacobs' last report was about the schools participating in 'International Walk to School Day', saying it was a big hit. Clara Barton said it was the best traffic day and that the school will continue to make Walking Wednesdays a weekly occurrence. She also reported that Clara Barton will give tickets for the 100 Mile Club to walkers that participate.

At the October 23 City Council Meeting, all Council Members were present. After the invocation, led by Pastor Tim Eaton of Edgewater Lutheran Church, the meeting started off with a presentation from Mayor Bootsma proclaiming the week of October 23-31 as 2013 Red Ribbon Week. There was also a presentation proclaiming November 2013 National Pancreatic Cancer Awareness Month in the City of Eastvale. The Riverside County Animal Control also did a presentation regarding the Integrated Canine Licensing Program, where they spoke about the services they provide, including vaccination clinics at their Van Buren and Clay location, the first Wednesday of the month in the evenings, and the third Saturday of the month in the mornings.

During the Public Comment and Citizen Participation section, Michael Armijo, from the Eastvale Chamber Of Commerce, said that he attended and represented the City Chamber at the Inland Empire's biggest mixer. He said that many showed interest in the City and joining the Chamber. The Chamber will host a breakfast on November 7 at 7:00 a.m. at Corky's Kitchen, with a presentation by the Board of Directors of the Chamber. He also said that two mixers will be held in November. The first event will be held on November 19 at Dickey's Barbeque in Eastvale, and the second will be held November 21 at the Chino Airport, alongside the Chino Valley Chamber of Commerce. He also updated the Council on the upcoming

edition of the Eastvale Community News, and for Council to submit articles to be printed. He says the newspaper staff is working hard to bring information to the City residents.

The following items were passed with a 5-0 vote: October 9 Regular Meeting Minutes, 5.2 Resolution of Support for the Coachella Valley Rail Project, 5.3 2013-14 SLESA (Cal COP) Funding, 5.4 Warrant Register, and 5.5 Warrant Register for Council-Related Items.

The Single Family Residential Registration, and Inspection and Crime-Free Rental Housing Program (Item 7.1) were passed with a 4-1 vote. Councilman DeGrandpre then read his statement from the October 9 Council Meeting, and discussed fines they could impose on a property owner, and the limitations regarding how high and when a fine can be imposed legally.

The Adoption of the City-wide Entryway Master Plan (Item 8.1) was passed 5-0, which will be brought back to Council if details need changing. According to the presentation by City Manager, Carol Jacobs, the purpose of the plan is to clearly identify entries into the City, to hopefully increase the local identity and civic pride. She presented different options for entryway identifiers with the City logo on each one. Monument type and way-finding directional signs were presented via Power Point presentation. The Council discussed the durability of the materials to be used to construct these monuments and they discussed whether the way-finding signage would meet or exceed height requirements for signs within the City.

The Eastvale Community Foundation CDBG Grant Process (Item 8.3) was passed 4-1, with discussion regarding the amount of funds allotted per child through the grant, and the verification process that would be implemented before funds are given to any family/child to be used for sport activities.

The approval of guidelines and logo for the Shop Eastvale Program (Item 8.4) was

passed 5-0, with a discussion about the Shop Eastvale Program's focus to offer residents incentives to shop locally, thus keeping revenue within the City. It is a free program for businesses within the City to participate in. Discount cards will also be supplied to participating businesses. There was also discussion about a City App being developed for smart phones, which will identify businesses participating in the Shop Eastvale Program. Punch cards will be used and a quarterly drawing was proposed.


The First Amendment to the Solid Waste Franchise Agreement with USA Waste California, Inc. (Item 8.2) was passed 5-0, and the Consultant Agreement for Professional Traffic Engineering Services (Item 8.5) was passed 4-1, both without discussion.

The meeting ended with the Council Communications section of the meeting. During this time, Council Member Rush discussed that vehicles have been driving around picking up scrap items in the neighborhoods and he questions if there is something that can be enforced in that regard. He also asked staff about beginning an investigation regarding Pit Bull and/or other animal breed sterilization ordinances. He asked that the enforcement and financial impact also be part of the investigation.

Council Member Howell discussed that the Corona-Norco Unified School District will possibly be changing board member districts for upcoming elections. She recommends that Eastvale residents look at maps, which are available online. Howell also announced that November 30 will be her last day serving on the City Council. She said she needs to spend more time at home with her children.


Mayor Bootsma said he will be attending the Riverside-San Bernardino Economic Forecast Conference on October 29. He also said that Eastvale now has two new bus shelters. Lastly, Bootsma said that a dairy will be leaving the City of Eastvale, and there will only be two dairies left.

# Eastvale decides to continue fight for vehicle license fees

in September with no resolution in sight, hope for seeing the funds seemed lost. Mayor Ike Bootsma had decided to stop fighting as he felt there was a better use of the \$3,000 dollars per month that was being paid to a lobbyist. Wildomar, Jurupa Valley and Menifee also pay \$3,000 per month. However, there seems to be a change coming and Bootsma now has hope that Eastvale may be able to get the funds back. According to Chuck Dalldorf, California Senator Richard Roth's Communication Director, "Senator

Roth's number one priority is getting this bill passed this upcoming legislative session". Nancy McFadden, a senior advisor to Governor Jerry Brown, has also said that their administration is committed to finding a long term solution to the cities' predicament in early 2014. The commitments of the Senator and Governor's offices, as well as conversations between city officials of all four cities affected by the cut, have renewed Eastvale's desire to fight for at least another budget cycle.

SB56, sponsored by State Senators Roth (D-Riverside) and Bill Emerson (R-Hemet), would have used property tax

revenue to restore millions in funds that were lost by the four newest California cities: Jurupa Valley, Eastvale, Menifee and Wildomar. While Eastvale was hit hard by the cut, the City of Jurupa Valley seems to have received the worst of it. Jurupa Valley incorporated just two days after the decision to divert funds was made. Last summer, state lawmakers had approved a measure that would have restored funds, but it was vetoed by Governor Brown. They lost \$6.7 million, half of their general fund budget, in the first year. The city has started the disincorporation process because if funding is

not restored during the 2014 budget year, Jurupa Valley will be out of money in 2015.

Another piece of legislation, Senate Bill 69 (SB69), was amended and contains almost

the same language as SB56. This bill, according to Senator Roth's office, is most likely to pass. SB69 is currently with the Assembly Rules Committee awaiting assignment to the Policy Committee in January 2014.

cording to an analysis by Patch of new FBI figures.

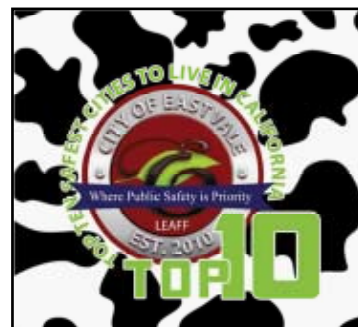
The ranking is based on violent crimes per 1,000 residents as reported by the FBI's Uniform Crime Reporting program.

Based on this data, the 20 safest cities over 50,000 population and their violent crime rate per 1,000 residents in 2012 were:

2. San Ramon – 0.61 crimes per 1,000 residents
3. Murrieta – 0.66 crimes per 1,000 residents

– 0.68 crimes per 1,000 residents

6. Eastvale – 0.74 crimes per 1,000 residents
7. Mission Viejo – 0.76 crimes per 1,000 residents
8. Palo Alto – 0.80 crimes per 1,000 residents
9. Yorba Linda – 0.81 crimes per 1,000 residents
10. Rocklin – 0.83 crimes per 1,000 residents
11. Chino Hills – 0.84 crimes per 1,000 residents
12. Camarillo – 0.92 crimes per 1,000 residents
13. Temecula – 0.94 crimes per 1,000 residents
14. Orange – 0.97 crimes per 1,000 residents
15. Cupertino – 0.97 crimes per 1,000 residents
16. Diamond Bar – 0.97 crimes per 1,000 residents
17. Arcadia – 0.99 crimes per 1,000 residents

20. San Clemente – 1.15 crimes per 1,000 residents

Violent crimes are defined as murder, rape, robbery and aggravated assault. Murrieta had a total of 70 violent crimes, Temecula 97, Menifee 87 and Eastvale 41, according to the FBI report.

The large city with the highest crime rate in California was Oakland at 19.93 violent crimes per 1,000 residents. Nationally the rate of violent crime in 2012 was 3.87 crimes per 1,000 residents.

The FBI cautions that there are "many variables that mold the crime in a particular town" and rankings "often create misleading perceptions adversely affecting cities and counties, along with their residents."

# Yorba School to Begin Phase 1 of Construction:

Yorba Elementary School, located at 8300 Fieldmaster St. in Eastvale is scheduled to begin the first phase of construction this month. The first phase will consist of in-house grading and underground utilities. This phase is expected to be completed by early next year. The second phase, which will complete the school, is dependent

on state funding. The first phase of Yorba Elementary School will cost around \$2.5 million and is planned to be completed by March or April of 2014, depending on weather and any other possible delays. The second phase is dependent on state funding at a cost of about \$12.3 million dollars to finish the school. According to Ted Rozzi, Asst. Superintendent of CNUSD, "the district is eligible for the funds and we

are one of the first in line to receive the funds". Every six months there is new qualification period and CNUSD is eligible on January 1, 2014. If the District is able to secure the funds, phase 2 would then start as early as spring 2014 with plans to complete the school by July 2015. These funds are also not dependent on any possible future bonds. The opening of this school will

bring much needed relief to Clara Barton Elementary School which is currently at capacity. Once Barton is relieved, Rosa Parks can also be relieved. Once the school is open, Rozzi states that there will most likely be an attendance boundary change to ensure students are properly distributed. break-ins reported by an Eastvale resident on our Facebook page (Facebook.com/EastvaleCommunityNews).

On Thursday, Oct. 3, 2013, at 8:30 a.m., a search warrant was served by deputies assigned to the Norco COPPS team and patrol, after they received information regarding an illegal cultivation of marijuana within a residential neighborhood. During the service of the search warrant, Jeffrey Berner, a 45 year-old resident of Norco, and Michelle Berner, a 45 year-old resident of Norco, were detained and arrested at the residence. Deputies seized 572 plants, 1.3 pounds of processed marijuana and numerous types of firearms inside the residence. Additionally, electricity was being bypassed around the meter, causing a serious fire hazard and resulting in approximately \$3,000 a month in stolen electricity. Jeffrey Berner was arrested for cultivation and possession of marijuana for sales and child endangerment, and Michelle Berner was arrested for child endangerment. This investigation is ongoing and anyone with information about this incident is asked to contact Deputy Raymond Ghiliotty at the Jurupa

Valley Station's Norco Office at (951) 955-2600.

On Saturday, Oct. 12, at 4:06 p.m., officers assigned to the City of Eastvale's Special Enforcement Team conducted a vehicle enforcement stop in the 14000 block of Chandler Street. An adult male driver and passenger were contacted and found to be under the influence of a controlled substance. The passenger was found to be on Post Release Community Supervision. A search of the vehicle revealed a large amount of methamphetamine, U.S. currency, and packaging materials for the sale of methamphetamine. The subjects were arrested and booked into jail at the Robert Presley Detention Center. They have been identified as Antonio Machado, a 56-year old resident of Eastvale, arrested for possession of methamphetamine for sales, transportation of a controlled substance, under the influence of a controlled substance, and committing a felony while out on bail; and Cesar Arceo, a 33-year old resident of Jurupa Valley, arrested for possession of methamphetamine for sales, transportation of a controlled substance, under the influence of a controlled substance, committing a felony while out on bail, and a violation of his Post Release Community Supervision. She said that some of her neighbors have reported seeing a suspicious red van in the neighborhood, and a young male has been going door to door claiming to be a carpet cleaner, but refused to provide any business cards or flyers when asked. On Wednesday, Oct. 23, at 7:00 p.m., a search warrant was served by officers assigned to the City of Eastvale's Special Enforcement Team, after they obtained new information regarding a residence being used for an illegal marijuana grow operation. During the service of this search warrant, Tung Tommy Gia Hua, a 33-year old resident of El Monte, was detained inside the residence. Officers discovered the residence had been modified for the sole purpose of cultivating, processing and packaging marijuana for sales. Officers seized 730 marijuana plants, packaging material and digital scales. Additionally, electricity was being bypassed around the meter, causing a serious fire hazard and resulting in approximately \$4,000 a month in stolen electricity. Gia Hua was arrested for cultivation of marijuana and grand theft of utilities and was booked into jail at the Robert Presley Detention Center. # CNUSD divides into 5 voting areas

for school board elections. CNUSD school board elections are at-large, meaning voters can cast votes for all five seats up for election. Trustee area elections are those that require voters to exclusively vote for candidates within their residential boundary. As CNUSD explores the adoption of establishing trustee areas, they have sought the feedback of the community about the proposed drafted trustee area maps. This change, if approved, would go into effect with the elections in November 2014, where members of the Board of Education will only be elected by voters who reside in the areas that the board members are elected from.

Using Data from the 2010 census, a private consulting group, in collaboration with the district, created election areas that would be roughly equal in population and in compliance with state law, the Federal Voting Rights Act, and the United States Constitution. Three conceptual trustee area scenarios have been created that divide the district into five areas and these have been presented to the community for feedback during four different meetings held last week throughout the Corona-Norco area. Participants were encouraged to ask questions, view information on bound-

aries and view a short presentation on the process.

CNUSD presented the considerations for the trustee areas at these meetings so that the community would understand the process and what is required for this to happen. First, each area would need to contain a nearly equal number of inhabitants. Second, each area is drawn to comply with the Federal Voting Rights Act. Third, each area must represent more than one jurisdiction/high school boundary. Finally, the areas must be compact and contiguous, respect communities of interest, respect incumbency and follow man-made and natural geographic features.

At last week's Eastvale Townhall Meeting, CNUSD Board Member, Bill Newberry, and Ted Rozzi, Assistant Superintendent of Facilities, shared some of the results of those meetings with Eastvale residents. According to Newberry, it appears that in early 2014 we will most likely be going in the direction of dividing the population into five trustee areas. This means that by the November 2014 elections, each area will be electing a school board member from their own area to represent them in the school district. The trustee draft maps can be viewed on CNUSD's website at [www.cnusd.k12.ca.us](http://www.cnusd.k12.ca.us), under Trustee Area Public Forums.

# Norco’s Silverlake project - what happened?

that completion of the project isn’t hoped for. If finished, the park will be used for equestrian and sporting events, as well as dog shows, car shows, weddings, corporate and community events, circus performances, camping, and more. The park would also join with nearly 120 miles of biking, jogging and equestrian trails. With 25 sports fields, six equestrian sand rings, an event center with climate-controlled barn, reception hall, and camping and recreational vehicle space, Silverlakes would definitely be a destination facility as well as a bonus to the City of Norco and the surrounding areas.

Will the project ever reach completion? Brandes agreed to provide updates at the City Council meetings each month, but since there is nothing new to report, he has not been present. Citizens of the area have a right to know, however, what is happening with the project. A lot of graded land doesn’t do anyone any good. Dave Henderson,

Norco Planning Commission Member, and his wife, Shirley, made a public presentation at the American Legion Hall to do just that.

On October 18, 2013, Henderson provided the facts surrounding Silverlakes:

- \$5.1 million was spent by the end of 2012.
- No authorization existed beyond \$3.7 million.
- No water, sewer, or road infrastructure is in place.
- Water/sewer municipal bond money appears to have been used for something other than the designated purpose.
- Inspections were not made.
- Documents required before any money was to be released are not with the City.
- The only loan that is contemplated in the Funding Agreement is for when bond funds are repaid by Balboa to the City over the next 30 years.
- Billing was not for the actual cost of facilities or discrete components, as was required.

Henderson said, “Putting the construction, billing and everything else we have discussed together, the only conclusion possible is: The Funding, Acquisition and Construction Agreement and the ground lease agreement were not followed by ANYONE”.

Henderson posed a lot of questions in his presentation, mainly, why wasn’t the agreement followed, and where was the City Attorney in all of this?

In speaking with Norco City Councilman, Harvey Sullivan, he has a few questions of his own. “Brandes accepted the property “as is”. The initial funding should have been used to lay the water, sewer and road infrastructure”, he says.

So why, then, did Brandes spend \$5.5 million to move in 300,000 yards of dirt instead of laying the infrastructure? Sullivan adds, “There is still some of the initial \$6 million set aside, so why isn’t it being used to lay the infrastructure now? No further requests for release of funds have been received. Why aren’t they moving forward?”

Brandes is apparently seeking funding to complete the project. To move

forward there is a requirement to provide a letter of authorization showing funding for \$36 million. The City of Norco has received nothing to date.

So where does this leave us? Sullivan says, “Both sides, Brandes and the City of Norco, violated the original agreement. Hamner Avenue was not widened by the City by the April 19 deadline, and Brandes did not use the land as intended. A wrong has been done by misleading the City Council and the public by wrongful use of the funds; people have enough trouble trusting their government. But we all hope the project will be completed”.

The current situation is awash in funding, reimbursement, legalities and mistrust. The City is going to have to amend the contracts and figure out some way of getting the project back on track. Lawyers say the case has been filed with the District Attorney, so time will tell what happens next.

When asked if Silverlakes is still a go, Sullivan says, “I certainly hope so! It will be a boon to all the areas surrounding it”.

Arco Gas Station, as well as three buildings for retail. Building one would house a convenience store, restaurant, and automatic drive-through car wash. Building two would house a sit-down restaurant, and Building three would house a drive-thru restaurant. Public Notices have been filed at Eastvale City Hall, Eastvale Library, and Riverside County Clerk/Recorder's office. Any questions on the project can be directed to Kanika Kith at (951) 258-8300

Eastvale Community Park: Located at the southeast corner of Citrus and Hamner, the new park will be constructed in two phases, with Phase I nearing completion. The initial 45 acres will include Lighted Sports Fields, Picnic Areas, Concession Stands, Restroom

Facilities and Parking. The park will also extend the Eastvale Trail, which will connect from the park to the Santa Ana River Trail (which will include over 110 miles from the San Bernardino Mountains to the Pacific Ocean upon completion). Be aware of traffic slowdowns on Citrus, from Sumner toward Hamner Avenue, as construction of the new housing development leading up to the park may cause additional delays.

Schleisman Road and Scholar Way Improvements: Preliminary work has begun on the land across from the schools on Scholar Way as contractors prepare for the new Copper Sky housing development. The completed project will result in fully improved and widened intersections reducing existing traffic congestion at the intersection, including two lanes in each direction

between Schleisman and Citrus; and enhanced pedestrian safety with new crosswalks and paths. Expect significant traffic delays around this area, and if possible, use an alternate route. Joining carpools; helping children form walking, biking or scooter groups; dropping children off for school earlier and picking up later, or in a different area; and allowing extra time will help alleviate frustration around the construction. Additional traffic controllers and increased security will be provided to help facilitate drop-off and pick-up times and maintain student safety. Two additional traffic officers will be enforcing traffic laws from 7:00 to 9:00 a.m. and 2:00 to 4:00 p.m. on school days through November 22.




