Eastvale Fights For License Fees

Eastvale - Eastvale city officials have decided to continue pursuing the funds from Senate Bill 56 (SB56) which will attempt to collect funds lost when lawmakers decided to divert vehicle license revenue to local law enforcement grants. DB Launches New Program To Reward Citizens

Diamond Bar – The City of Diamond Bar launched a new program on Nov. 15, called "Report for Reward", which will reward helpful citizens up to \$500 in exchange for information that leads to the arrest or conviction of a person damaging property as a result of a burglary.

City officials say that the purpose of this program is to help

combat residential and vehicular crimes within city limits.

"The Report for Reward program provides a mechanism by which the City can financially reward reports by members of the public that lead to the identification and arrest of persons who damage or destroy property while attempting or

Increase In Walnut Burglaries Causes Concern

Walnut – Ten burglaries were reported in the City of Walnut, and that was just last week. Are they all related and some sort of an anomaly, or has Assembly Bill 109 really proven to increase our crime rates and put

citizens in jeopardy?

The Little Hoover Commission, an independent state agency designed to investigate state government operations, states that crime is trending upward. In Los Angeles County, the Sheriff's August 31, 2013 crime statistics show burglaries

in Walnut have increased 63% (from 73 to 119); and grand theft auto is up 65% (from 17 to 28). Just a few months later, LASD statistics say 184 burglaries have been reported year to

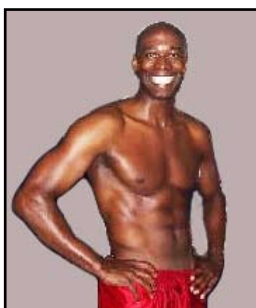

While at the ATM drive-through, a woman straddled both lanes in a two-lane isle. I've been there a thousand times and not one person has ever straddled these lanes, they just pick one. Sometimes the line moves quickly, other times you have to wait while the cars next to you move right through. It's a gamble, but we make a decision and we accept it.

Maybe it was the long day or maybe I just felt short-tempered, but while the woman straddled the lanes, I went around her car, and I picked the left lane. She got out of her vehicle and told me; "I've been waiting, you can't go around me." I explained the unwritten policy of the drive-through ATM machine. She angrily got back into her car and waited again. As I drove up to the machine, I felt so uncomfortable. I knew she never should've sat there and straddled both lanes, but who am I to react to her misdirection? The uncomfortable feeling made me sick inside, I knew that I never should've gone around her. So I backed up, allowed her to go first, calling out to her; "I'm sorry, go ahead of me." She pulled up to the machine, finished her transaction, and her last words were; "Thank you for being fair."

and present issues, views, and concerns in a dignified, fair, and an understandable manner. To simply be a human being.

then I just should've waited behind her and not given it another thought. Instead, I almost ruined her entire day, and who knows what that could've done to her family and friends.

We need to understand the true meaning of sharing experiences, applying yourself, being honest, open, and sincere. It will bring you peace when you remember that you have so much to contribute to life, let's not waste it on

bitterness, anger, frustration, or unfairness. Instead, let's focus on the good things.

The power we hold within ourselves is worthless when we misdirect our hearts by allowing our minds to take over. I believe the truest form of life is not just having the power to get your way, but having the power to help others find their way. 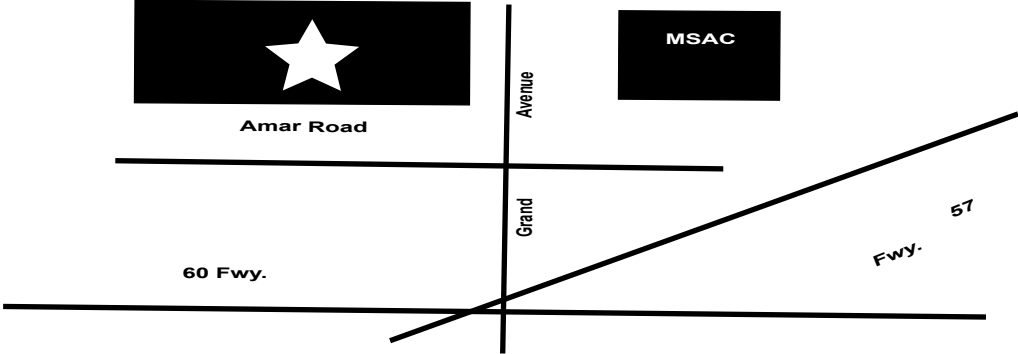

Eastvale fights for license fees

our city, but the cities of Jurupa Valley, Wildomar and Menifee, who all were expecting that money as part of their operating budgets. The four cities had been working together with a lobbyist in Sacramento to get the funds reinstated, but were unsuccessful in past budget years.

With lawmakers recessing in September with no resolution in sight, hope for seeing the funds seemed lost. Mayor Ike Bootsma had decided to stop fighting as he felt there was a better use of the \$3,000 dollars per month that was being paid to a lobbyist. Wildomar, Jurupa Valley and Menifee also pay \$3,000 per month. However, there seems to be a change coming and Bootsma now has hope that Eastvale may be able to get the funds back. According to Chuck Dall-

dorf, California Senator Richard Roth's Communication Director, "Senator Roth's number one priority is getting this bill passed this upcoming legislative session". Nancy McFadden, a senior advisor to Governor Jerry Brown, has also said that their administration is committed to finding a long term solution to the cities' predicament in early 2014. The commitments of the Senator and Governor's offices, as well as conversations between city officials of all four cities affected by the cut, have renewed Eastvale's desire to fight for at least another budget cycle.

SB56, sponsored by State Senators Roth (D-Riverside) and Bill Emerson (R-Hemet), would have used property tax revenue to restore millions in funds that were lost by the four newest California cities: Jurupa Valley, Eastvale, Menifee and Wildomar. While Eastvale was

hit hard by the cut, the City of Jurupa Valley seems to have received the worst of it. Jurupa Valley incorporated just two days after the decision to divert funds was made. Last summer, state lawmakers had approved a measure that would have restored funds, but it was vetoed by Governor Brown. They lost \$6.7 million, half of their general fund budget, in the first year. The city has started the disincorporation process because if funding is not restored during the 2014 budget year, Jurupa Valley will be out of money in 2015.

Another piece of legislation, Senate Bill 69 (SB69), was amended and contains almost the same language as SB56. This bill, according to Senator Roth's office, is most likely to pass. SB69 is currently with the Assembly Rules Committee awaiting assignment to the Policy Committee in January 2014.

and break-ins in recent weeks, causing enough concern for the issue to be addressed by the council.

Ray Ayers has been residing in Walnut for 15 years. He said he was looking into starting a neighborhood crime watch with the help of the Walnut Sheriff's department, following break-ins at his property on Walnut Canyon Road last week. Ayers said his house was burglarized, and was completely trashed following a violent forced entry which resulted in his wife's jewelry being stolen.

"We need to spread the word, this is a serious issue," said Ayers who added his neighbor's mailboxes were also broken into several months ago and adding that the burglaries have become the number 1 issue of concern among area residents.

Ayers said his daughter works with social media and was successfully able to locate some of the stolen items including his safe and his wife's passport, some of the items turning up in Baldwin Park, leading him to believe the crimes were not committed by Walnut residents.

"I think all of us are very supportive," said Mayor Tony Cartagena. "We encourage our constituents to form neighborhood watch programs."

Council member Mary Su added she would like more resi-

dents to volunteer to help patrol the neighborhoods and become more proactive in monitoring suspicious activities near their properties. "Our Sheriff station is very responsive," said Su echoing other council members who said Walnut Sheriffs usually respond to calls within several minutes, but she said the city still needs more volunteers to maintain vigilance.

According to data made public by the Los Angeles County Sheriff's Department whose deputies and officers patrol Walnut and Diamond Bar, Walnut has experienced a year-to-date increase of 72 percent in burglaries compared to last year, (184 reported incidents thus far compared to 143 total in 2012) and a spike of nearly 80 more reported incidents than a year ago. Walnut has also experienced slight year-to-date increases in the areas of robbery and grand theft auto.

Cartagena attributes the increases to a state mandate of early release of prisoners. "If your offense is not major, you can be released and that negatively impacts the City," Cartagena said Walnut is negotiating with other cities to lobby Sacramento for additional funding to mitigate the problem.

"If you see something strange, be a good neighbor and call the Sheriff Department," said council member Eric Ching, "they can be there in two to three minutes."

Ching said the city Manager is

aware of the issue, while Cartagena added staff has asked for information on burglaries which have taken place in the city within the past six months. For more information about this issue, see the story about recent crimes on page 1.

In other council matters, the council heard from representatives of non-profit organizations including one representing parishioners of St. Lorenzo Ruiz Parish's basketball league who complained to the council about being unable to schedule gym time at the teen center, due to other activities like table tennis occupying the space. The issue was placed on the agenda for the upcoming Parks and Recreation Commission meeting scheduled for Nov. 19.

The council also approved a second reading of their municipal code amendments dealing with zoning to add emergency shelters, transitional housing, single-room occupancy units as mandated by state law, approved an ordinance to expand applicability of the Existing Standard Urban Stormwater Mitigation Plan requirements, and accepted the work performed by a contractor on the Creekside Drive Street Rehabilitation Project, among other actions as part of their consent calendar.

The next regular meeting of the City Council is scheduled on Dec. 11, at 7 p.m. in the Council Chambers, 21201 La Puente Road.

degree robbery and two felony counts of attempted second degree robbery. He faces a maximum sentence of 10 years and six months in state prison at his sentencing, Jan. 17, 2014, at the Central Justice Center, Santa Ana.

Between Dec. 20, 2011, and

March 21, 2012, Franks committed 10 robberies at nine different banks in Orange County. The bank chains included Bank of America in Anaheim, Chase Bank in Laguna Hills and Laguna Niguel, Citibank in Irvine, two robberies at the Schools First Federal Credit Union branch in Anaheim, Union Bank in Newport Beach, US Bank in Irvine and Ladera Ranch, and Wells

Fargo in Irvine.

Franks attempted to rob a bank teller at the Citibank branch in Irvine and the US Bank branch in Irvine where he committed robberies before.

In each of the cases, Franks carried out similar acts: entered the bank wearing distinctive headgear which included a motorcycle helmet or beanie and sunglasses, approached a

bank teller, and slipped the teller a note which stated he had a gun and demanded money. He caused the tellers to give him the money out of fear. Franks took the money and walked out of the bank.

The case was investigated by multiple agencies including Anaheim Police Department, Federal Bureau of Investigation, Irvine Police Department (IPD), Newport Beach Police Department, Orange County Sheriff's

Department, and Riverside County Sheriff's Department.

On May 4, 2012, IPD arrested Franks at his home in Riverside. At the time of his arrest, Franks had money fanned out in the passenger side of his vehicle, a ripped up demand note, and several used Band-Aids he used to cover his fingertips.

Senior Deputy District Attorney Lynda Fernandez of the Felony Panel is prosecuting this case.

executing a residential or vehicular burglary,” according to a City news release.

The first reading of this program occurred at the Oct. 1 city council meeting, where it was unanimously approved for implementation.

Assistant City Manager, David Doyle, said in a statement that the Report for Reward program lends reinforcement to the

cooperative effort by City staff, Sheriff deputies, and community members to deter criminals from coming into the City to take what doesn't belong to them.

The City of Diamond Bar is also working hard to aggressively market the program via all City communication mediums.

“We want word to get out beyond just Diamond Bar residents – this program is open to all members of the public, with the exception of City and Sheriff's employees,” said Cecilia Arellano, Public Information Coordinator for the City of Diamond Bar.

“The intent of this new program is to encourage everyone – whether they live here, work here, or are just visiting – to lend their eyes and instinct to our shared goal of keeping burglars out of our city,” Doyle said in the statement.

“Our hope is that the financial incentive gives individuals that extra push to be actively vigilant of their surroundings and

immediately report suspicious activities to the Sheriff's station,” he added.

After suspicious activity is reported, representatives from the City and the Sheriff's Station will review the reports and determine if a financial reward is earned, then decide how much the reward would be.

“To qualify for a reward, the information provided will have been considered as playing a key role in the identification and arrest of individuals who dam-

age or destroy property while attempting or executing a residential or vehicular burglary,” according to the City release.

To participate in the “Report for Reward” program, report suspicious activity to the Sheriff's Station at (909) 595-2264. However, if the burglary is in progress, please call 9-1-1.

date, up from 107 at this time last year.

With AB109, the prison realignment assembly bill signed by Governor Jerry Brown, over 43,000 prisoners are now serving time in local jails instead of state prisons, and due to overcrowding, some "low risk" offenders are being released early to county parole officers. Some Walnut residents expressed concern at the City Council meeting on November 13, and the City Council is reportedly gathering information on the number of prison releases to the area to see if there is any correlation.

One such resident, Ray Ayers, a victim of one of last week's burglaries, said that mailboxes on and around Walnut Canyon

Road have been broken into over the last month, and now the houses have been broken into in the same area.

"Ours was a forced entry using a crowbar. Our next door neighbor's son was home when the attempted burglary was done, and our neighbors across the street came home to find their door wide open from a forced entry," said Ayer's wife. "Another neighbor told us that a burglary occurred up the street from her as well."

Ayer's wife further stated that it took 45 minutes for the sheriff to come to their home. When the investigating detective returned the next day to fingerprint, she mentioned there were seven other homes burglarized that she had to print.

Violent crimes may have decreased, according to LASD statistics, but property crime is

up. Ayers says "It's only a matter of time before someone is seriously hurt."

Now, more than ever, Neighborhood Watch programs are critical. The Walnut/Diamond Bar Sheriff's Station is committed to helping organize this program throughout their jurisdiction, with 70 programs already in effect. A neighborhood working together can make a difference.

DB council corner: meeting shaken with mayor's cup fallout

"Business of the Month" for November for all the sponsorship services rendered to the community and the financial stability provided by the restaurant.

"I'm very honored to be here to be recognized as 'Business of the Month' for the City of Diamond Bar," Paul Aoun, managing partner of Chili's, said.

After members of City Council honored Aoun with a certificate for Business of the Month, City Manager James DeStefano reported on the success of the Diamond Bar Public Library, with the strong numbers concerning circulation and 21,600 monthly users for the Diamond Bar Library.

DeStefano also noted that the library is looking into more eBooks and longer hours for the

community.

During public comment, Tim Saunders, Pomona resident, voiced his concerns involving the level of violence he witnessed at the Mayor's Cup football game between Diamond Bar High School and Diamond Ranch High School.

Diamond Bar Mayor Jack Tanaka said he was witness to the outrageous behavior from both schools and that he hoped that both schools districts would work together to stop future aggression at football games.

"After all; we are one City; one Diamond Bar," Tanaka said.

The Mayor's Cup is an annual football game that highlights the rivalry between Diamond Bar High School and Diamond Ranch High School. The original Mayor's Cup took place in 2011 and has been held by Diamond Ranch

since the cup's inception.

After listing the schedule of future events, DeStefano then listed 12 items on the consent calendar which the City Council members unanimously approved.

Among the items approved were the minutes for the Oct. 15 City Council meeting, the Aug. 22 Parks and Recreation Commission, the Sept. 12 Traffic and Transportation Commission, and Sept. 24 Planning Commission meeting, the ratification of check register for Oct. 10 through Oct. 30 totaling \$1,626,885.63, the treasurer's statement for September, and the second reading ordinance 11(2013): amending Division 5 of Chapter 8.12 of Diamond bar Municipal code for Standard Urban Storm Water Mitigation.

Also approved was the Contract Amendment No.1 in the amount

of \$20,000 with Lilley Planning Group, Inc., the second reading of Ordinance No.09 amending Title 15 of the Diamond Bar code and adopting the 2013 California Building Code, Approval Amendment No. 3 to Memorandum of Understanding between the City and the Los Angeles County Metropolitan Transportation Authority for State Route 60/Lemon Avenue Partial Interchange Construction, the second reading of Ordinance 10(2013) amending Title 10 by adding Section 10.16.115 to the Diamond Bar Municipal Code for parking on city streets for the purpose of sleeping, and adopting Resolution 2013-XX: a resolution granting consent and jurisdiction to the County of Los Angeles in the matter of County Lighting Maintenance District 10006 and County Lighting District LLA-2.

The council then unanimously approved the only item on the Council Consideration Calendar, which was Ordinance No. 03(B). The ordinance identified the temporary re-location of the Diamond Bar City Council meetings to Diamond Bar City Hall at 21810 Copley Drive.

During the section for council member's comments, Council Member Steve Tye spoke out against Tanaka's decision to advice to cancel the 2013 Mayor's Cup.

"I think you got bad advice, somewhere along the line, to determine that the Mayor's Cup should be cancelled," said Tye. "I think in this instance you showed no leadership."

Tye claimed that Tanaka's advice would further promote division between Diamond Bar and Diamond Ranch and that future athletes would be missing a great opportunity to take part in the Mayor's Cup.

Tye then excused himself from the remainder of council comments.

Tanaka defended his stance by stating that the Mayor's Cup would have been better if it were thought out by schools as opposed to being imposed by the City of Diamond Bar.

"I think it presents an opportunity for both schools maybe to dialogue, with both principals with the support of the superintendent, that we can plan on an activity that's going to be positive for both schools," Tanaka said.

Tanaka said that the events of the Mayor's Cup gave a "black-eye" to the City of Diamond Bar due to the fight that ended the game and the behavior shown by both schools.

The Diamond Bar City Council officially adjourned at 7:50 p.m. on Nov. 5
