## DUI Checkpoint Controversy

**Eastvale** – It seems like every time information is published about an impending Sobriety Checkpoint, or the results of one, citizens on Facebook and other social media sites post rants implying everything from a violation of civil or constitutional rights, to just a way for the city to make money. But what about another perspective?

DUI Checkpoints, or roadblocks, involve law enforcement officials stopping every vehicle, or every random vehicle, on a public roadway and investigat-

ing the possibility that a driver may be too impaired to drive. They can occur at random, on research obtained by law enforcement, or even be set near exit points of public events to prevent large numbers of drunk drivers from being released into traffic simultaneously.

The National Highway Traffic Safety Administration (NHTSA) says that in 2012, just in California, more than 10,000 people died in alcohol-impaired driving crashes; that's one

## Illegal Sterilization At Chino Prison

**Chino** – In a review concerning female inmate sterilizations occurring between fiscal years 2005-06 and 2012-13, state auditor, Elaine M. Howle, reported on some disturbing facts discovered in some California prisons.

The June 19 audit revealed that during the aforementioned period, 144 female inmates were sterilized by bilateral tubal

ligation, and the Receiver's Office of the California Correctional Health Care Services at times failed to ensure that the inmates' consent was lawfully obtained. 39 inmates received the procedure – 11 of those women incarcerated at Chino – with deficiencies in the process.

In 27 of those cases, there

**Corona** – On Wed., July 16, one of the items on the City of Corona's City Council agenda involved deciding the future of the old Council office building. This entailed voting on whether or not to allow Christian Arts and Theatre of Corona, a local children's theatre program, to become the building's new tenants.

According to their website, “Christian Arts & Theatre of Corona (CAT) is an after-school theater and visual arts educational program for students ages 6 to 18. Church. While the location of the classes and rehearsals has repeatedly changed, one thing has remained constant for a very long time: the Corona Civic Center Theater has continued to house their musical performances.

CAT's artistic director, Cindy Monroe, was informed of the

bit of a premature tagline. In recent reports there have been as many as 17,000 violations in a single day since Orange County toll roads recently eliminated manned cash-collecting toll booths and became all electronic. Because of this transition, some of the fees are being waived for first-timers, but toll agencies are going to

start enforcing penalties soon enough. The Transportation Corridor Agency has eliminated the manpower in favor of electronic signaling for which commuters can utilize a special transponder, or pre-pay tolls online. There are always violations that occur in the toll roads, but the new system is obviously a source of mass confusion. Many drivers have been reported pulled over on the side of the road near the electronic booths trying to

figure out what to do. With an estimated 250,000 motorists using the four Orange County toll roads each day, that's a lot of perplexity. If you sign up for an account online and provide bank or credit card debit access, you can receive a transponder and not worry too much about it. Those without accounts are required to pay one-time tolls online within 48 hours of their usage or suffer the consequences. The agencies are trying to educate consumers on the new

system and assist with the transition. For now they are said to be waiving the \$57.50 violation penalty fee through Labor Day, as long as the toll is paid within a 30 day time frame. They are also installing more signage, and flashing information on nearby freeway information boards to help guide those heading for the toll booths. It makes sense that the confusion has added significantly to the number of calls coming into the toll agencies. They have temporarily increased customer

service representatives to help alleviate the backlog and provide assistance. Visit [www.thetollroads.com](http://www.thetollroads.com) to gather more information. You can pay online, or even download their payment app, One-Time Toll, to help you on your way. Just remember, don't stop at the booth, just head on through or you'll hold up the line. If you go through a toll booth, you'll have to pay it in some fashion. With a little patience and education, it can be penalty-free.

past several weeks.

According to the SGV Mosquito and Vector Control District – or the Vector Inspectors – WNV is present in the San Gabriel Valley every year. You can help to eradicate this disease from the area by taking an active stance against it through prevention. The Vector Inspectors recommend that you walk around your property and dump out any accumulated water in buckets, barrels, old tires, pots, and other containers. Report any green and stagnant pools, ponds and fountains, as they can breed thousands of mosquitoes weekly; and report all dead birds to [www.westnile.ca.gov](http://www.westnile.ca.gov).

WNV is primarily transmitted from bird to bird by mosquitoes. In some species it is nearly always fatal. The presence of dead birds in a neighborhood is often the first indication of WNV activity.

WNV originated in Africa and was first recognized in the United States in 1999. There is currently no cure; however, most people don't exhibit any symptoms. Since 2003, there have been more than 4,000 reported infections and 145 deaths in California, according to the Centers for Disease Control (CDC), so the threat should be taken seriously. Symptoms include fever, headaches, body aches, skin rashes and nausea, which can present anywhere from

five to 15 days after exposure, and can last several days or months.

Popular Creekside Park is the venue for Walnut's summer concert and movie series, and there are a number of precautions you can take to prevent infection during this event or any outdoor activity.

Mosquitoes are most active from dusk to dawn, and when enjoying warm summer evenings, be sure to wear loose-fitting long pants and sleeves, and shoes and socks. Treating exposed skin areas and outside clothing with repellents containing DEET, Picaridin, and oils of lemon eucalyptus can also be helpful, according to the CDC.

every 51 minutes. Further, 28 percent of all traffic deaths were alcohol related, not to mention the estimated \$37 billion that these accidents cost every year. Those are some statistics the public should surely like to see reduced; significantly.

According to California Watch, DUI Checkpoints have saved countless lives on the nation's roadways and have brought thousands of drunken drivers to justice. And by inspecting driver's licenses, police catch motorists driving unlawfully, typically without insurance, and temporarily remove them from the road.

As far as ranting about legalities, California Vehicle Code 2814.2VC authorizes these inspections. DUI Checkpoints have also been held valid under both the United States and California constitutions. The California Supreme Court states that DUI Checkpoints are administrative inspections (akin to airport screenings) and as such they are an exception to the 4th Amendment rule that an officer must have probable cause to initiate a California DUI investigation.

In a recent interview with Captain Jason Horton from the Eastvale Police Department, he said, "I'd like to make one thing perfectly clear. We do not hold checkpoints for any financial gain. First of all, we are a public agency bound by the laws of the State of California and funded by the office of Transportation Safety, and we are not allowed to 'make money'. But more importantly, these checkpoints are for education and notification that we have a zero tolerance for driving under

the influence. We use real statistics to show that there is a need for these checkpoints in our city. Our goals are to reduce collisions and injuries and remove impaired drivers from the road. We have made arrests, but I think everyone can agree that we do not want these people on our Eastvale streets."

The latest DUI Checkpoint conducted by the Eastvale Police Department occurred on July 25 near Schleisman and Archibald between the hours of 7 p.m. and 3 a.m. The operation examined 1,005 vehicles, and resulted in one DUI arrest, five sobriety field tests, three citations for unlicensed drivers, one citation for a suspended license, 13 citations for various vehicle and/or penal code violations, and one towed vehicle. So what if that checkpoint netted ONLY one DUI arrest. What if that driver had killed someone? What if that someone was in your family?

The nearby Chino Police Department successfully conducted a DUI Checkpoint on July 19 that resulted in the arrest of four subjects that were driving under the influence, as well as another for drug related charges. What if those five drivers were heading for Eastvale?

According to Horton, checkpoints are placed in locations that have the greatest opportunity for achieving deterrence, and provide the greatest safety for officers and the public. Locations are based upon research and statistics; the byproduct is education and awareness.

So, when you read social media comments about these checkpoints invading one's privacy, or that the police are

just trying to generate revenue for the city through citations, remember that the bottom line is that these checkpoints have been shown to lower DUI-related deaths and injuries. NHTSA says that checkpoints have provided the most effective documented results of any of the DUI enforcement strategies. According to the Eastvale Police Department, a major component of these checkpoints is the deterrent effects they have on those who might drive drunk or drug impaired. The knowledge of a checkpoint in the area of "celebration" encourages the use of designated drivers, less drinking, and more planning. That can only be a good thing. As they say, "Drunk Driving: Over the Limit, Under Arrest." It's the law.

The next time you see a DUI Checkpoint in place, don't panic or become agitated. Officers are courteous, efficient and professional, and they are just trying to keep you safe. What have you got to hide?

Horton says that officers at checkpoints rarely issue citations unless the situation warrants it. If a citation or enforcement ticket is written, a portion of the money collected goes to the state for court fees, and a portion comes back to the city. But they are not out there to increase revenue, by any means.

And yes, there is definitely a profit for the City. The proceeds derived from removing impaired drivers from the road, even if the net revenue was just one individual - and what if that individual was one that might have run a red light you were crossing against - is worth more than any citation could ever yield. A new perspective to consider.



possibility of a new home for the theater group. This “home” was located only a few steps from the Civic Center Theater that the CAT families know and love. “It’s such a beautiful place! Our kids and families will love this new home,” said Monroe.

On July 16, the council chambers were filled with many of the CAT families who had come

to show their support for the organization. On the Consent Calendar, the 9th item stated: “City Council directs the City Attorney to prepare a lease agreement between the City and Christian Arts Theater, using the City’s standard Historic Civic Center Lease Agreement...” The agreement would be for a five year lease, plus a five year extension.

The council members then took the time to share a few words about CAT with those

present and talked about the positive impact the organization’s relocation would have on the community, specifically in downtown Corona. Council Member Stan Skipworth enthusiastically stated, “This is an opportunity to keep our community alive.”

Finally, it came time for the Council to vote. The item was passed 5-0 in favor of allowing CAT to begin leasing the building. The news brought enthusiastic cheers and applause from

# Illegal sterilization at Chino prison

was no evidence that a physician signed the required consent forms asserting that the patient was mentally competent and therefore understood the lasting effects of the procedure; in 18 cases there was a violation of the required waiting period between consent and procedure. In some cases, the physicians falsified the consent forms, indicating that the proper waiting period had passed when it clearly had not. In all there were numerous illegal surgeries and other violations of the state’s informed consent law.

For one case in particular for a pregnant inmate at the Chino prison, a physician filed a form requesting approval for a pregnancy evaluation and treatment. Nothing on the form indicated a request for sterilization; the woman was sterilized, regardless, during a cesarean section delivery which was performed 17 days before the woman’s expected delivery date. A review of her medical records did not indicate any emergency conditions requiring an expedited delivery or sterilization.

Auditors have begun to urge federal officials to give the names of the physicians in-

involved in the illegal surgeries to the Medical Board and the California Department of Public Health for further investigation and possible disciplinary action.

Prison advocates and former inmates say that prison medical staff targeted those who were deemed likely to return to prison in the future. The audit states that all the women who received tubal ligations had been in prison at least once before, and were repeat offenders. The prison medical officials have denied any ill intent; however, the integrity of all these incidents is in question.

This integrity, or lack there-

of, leads one to remember California’s dreadful history regarding such things, labeled Eugenics. Wikipedia states that as an early leading force in the field of Eugenics, California became the third state in the United States to enact a sterilization law, forcing 20,000 sterilizations between 1909 and 1963. By 1921, California had accounted for 80% of the sterilizations nationwide. This continued until World War 2, after which the number of sterilizations began to decrease, largely due to the fallout of Hitler’s eugenics movement. It is reported that Nazi Germany sought the advice of the

California’s eugenics leaders in the 1930s. More current reports tout the sterilization as a way to avoid welfare benefits for unwanted children.

In response to the audit, the state prison health department generally agrees with the findings, and noted that steps have since been taken to improve the situation. A bill has now been introduced that would ban all inmate sterilizations for birth control purposes. In May, the Senate unanimously approved SB 1135, and the measures are now being taken up by the Assembly.

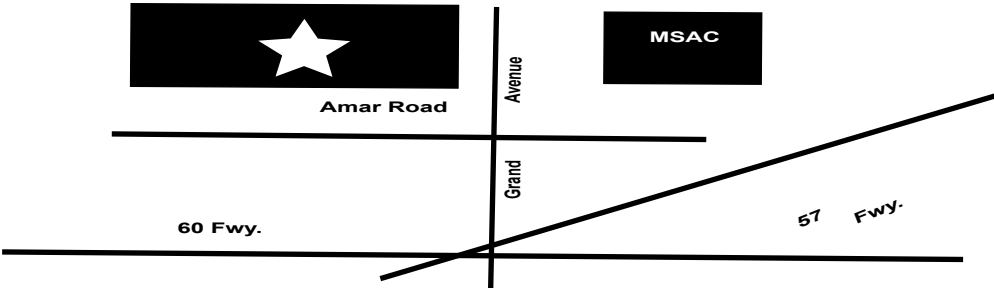
