## Rent or Buy?

Most people start their independent living when they first move out of their parent's home by renting.

They either choose to rent a room at another person's home, or possibly move into a friend's apartment. Many times they go from that living arrangement to sharing the cost of renting an apartment or house together with a few friends or just someone else.

Although everyone has their own decisions to make, and many different circumstances, across our country, we tend to follow a consumer pattern throughout our lives. Many financial analysts have studied the consumer cycle, and an established pattern has been the following for our society at large: one first starts working in their early late teens and into the early 20's, and then family formation follows in the mid-twenties to mid-thirties. Typically, at the stage of family formation and into the cycle of a young family is when most of us address the issue of "Buy-

ing versus Renting". At this stage, there are usually young children in the household, and the provision for a home with a yard for the children to play in becomes a major concern.

Currently, the rental rates are very high, and have been increasing substantially at 5% plus per year over the last 6-7 years. This highlights the need to stabilize the monthly housing cost, and with current interest rates, it is a very good time to lock in a low rate by buying a home. Many economists are predicting interest rates will increase this year. Just this week, the Federal Reserve approved its second rate hike of the year, increasing its benchmark interest rate by one-quarter percent. This rate hike eventually gets spread out to consumer interest rates.


There are many other factors that come into making a decision on whether to Rent or Buy. Next week, I will provide in more detail those factors, as well as show a point by point comparison on the options.

# History 101

## June 17, 1885: Statue of Liberty Arrives in New York Harbor

On this day in 1885, the dismantled Statue of Liberty, a gift of friendship from the people of France to the people of America, arrives in New York Harbor after being shipped across the Atlantic Ocean in 350 individual pieces packed in more than 200 cases. The copper and iron statue, which was reassembled and dedicated the following year in a ceremony presided over by U.S. President Grover Cleveland, became known around the world as an enduring symbol of freedom and democracy.

Intended to commemorate the American Revolution and a century of friendship between the U.S. and France, the statue was designed by French sculptor Frederic-Auguste Bartholdi (who modeled it after his own mother), with assistance from engineer Gustave Eiffel, who later developed the iconic tower in Paris bearing his name. The statue was initially scheduled to be finished by 1876, the 100th anniversary of America's Declaration of Independence; however, fundraising efforts, which included auctions, a lottery and boxing matches, took longer than anticipated, both in Europe and the U.S., where the statue's pedestal was to be financed and constructed. The statue alone cost the French an estimated \$250,000 (more than \$5.5 million in today's money).

Finally completed in Paris in the summer of 1884, the statue, a robed female figure with an uplifted arm holding a torch, reached its new home on Bedloe's Island in New York Harbor (between New York City and Hudson County, New Jersey) on June 17, 1885. After being reassembled, the 450,000-pound statue was officially dedicated on October 28, 1886, by President Cleveland, who said, "We will not forget that Liberty has here made her home; nor shall her chosen altar be neglected." Standing

more than 305 feet from the foundation of its pedestal to the top of its torch, the statue, dubbed "Liberty Enlightening the World" by Bartholdi, was taller than any structure in New York City at the time. The statue was originally copper-colored, but over the years it underwent a natural color-change process called patination that produced its current greenish-blue hue.

In 1892, Ellis Island, located near Bedloe's Island (which in 1956 was renamed Liberty Island), opened as America's chief immigration station, and for the next 62 years Lady Liberty, as the statue is nicknamed, stood watch over the more than 12 million immigrants who sailed into New York Harbor. In 1903, a plaque inscribed with a sonnet titled "The New Colossus" by American poet Emma Lazarus, written 20 years earlier for a pedestal fundraiser, was placed on an interior wall of the pedestal. Lazarus' now-famous words, which include "Give me your tired, your poor/ Your huddled masses yearning to breathe free," became symbolic of America's vision of itself as a land of opportunity for immigrants.

Some 60 years after President Calvin Coolidge designated the statue a national monument in 1924, it underwent a multi-million-dollar restoration (which included a new torch and gold leaf-covered flame) and was rededicated by President Ronald Reagan on July 4, 1986, in a lavish celebration. Following the terrorist attacks of September 11, 2001, the statue was closed; its base, pedestal and observation deck re-opened in 2004, while its crown re-opened to the public on July 4, 2009. (For safety reasons, the torch has been closed to visitors since 1916, after an incident called the Black Tom explosions in which munitions-laden barges and railroad cars on the Jersey City, New Jersey, waterfront were blown up by German agents, causing damage to the nearby statue.)

Today, the Statue of Liberty is one of America's most famous landmarks. Over the years, it has been the site of political rallies and protests (from suffragettes to anti-war activists), has been featured in numerous movies and countless photographs, and has received millions of visitors from around the globe. ■

We do not expect you to run from your problems or your anxieties by abusing alcohol, prescription or illegal drugs; this is how you teach us to not deal with life's anxieties and pressures. We do not expect you to lose your temper and mistreat us. But if you do, we expect an explanation and an immediate apology. Otherwise we'll carry those memories and emotions and they could haunt us for the rest of our lives.



It's no fun treading through life as though you're a thousand pounds too heavy, and a hundred points too stupid. It not fair to give us false identities because you're too insensitive to seek help for your insecurities and your lack of parental guidance. We expect you to fix your problems before you bring us into the world. And if you do not, fix them while we are here. Fix them in front of us, explain, and be honest. Or we will one day find out the truth about our lives and the truth about who you really are.

You do have the opportunity to give us enlightening answers before we ask those confront-

ing questions. And you have the ability to avoid those questions by being open and honest while giving an effort to be a better person. Your attempts to fix yourself will allow you some vindication and will allow us to feel better about who you really are.

My philosophies reach out like child's embrace, although I am physically an adult. But I, or WE, as there are many of us who are labeled "adult children" still hold childlike emotions for the lack of guidance we received in our adolescence. And for the lack of communication and vision that we experienced we stay victims. But as each day gets better, we try to correct ourselves into being a better people, continually fighting to reach a realm that I call "normal." And as we become victorious from each battle we can't seem to avoid, deep in our hearts we know it's a war that we may never win.





## Crispy Chicken Parmesan Salad

with Spinach and Roasted Potatoes

BY HELLO FRESH

**Cooking Time:** 30 mins

**Servings:** 4

**Nutrition:** 537 Calories

**Ingredients:**

- Spinach- 10 oz
- Chicken Breasts- 24 oz
- Garlic Powder- 2 tsp
- Lemon- 1
- Yukon Potatoes- 24 oz
- Panko Breadcrumbs- 1/2 cup
- Parmesan Cheese- 1/2 cup
- Sour Cream- 6 tbsp
- Olive Oil- 8 tsp
- Salt
- Pepper

1. Prep: Wash and dry all produce. Preheat the oven to 450 degrees. In a shallow dish, combine the panko, Parmesan cheese, garlic powder, and a pinch of salt and pepper. Cut the potatoes into 3/4- inch cubes and toss on a baking sheet with a drizzle of olive oil and a large pinch of salt and pepper.

2. Roast the potatoes: Place the potatoes in the oven for 25 minutes, flipping once, until golden brown and tender.

3. Working one at a time, place the chicken breasts between two pieces

of plastic wrap. Pound with a rolling pin, mallet, or heavy-bottomed pan until 1/2-inch thick. Season with salt and pepper.

4. Place the chicken on a lightly oiled baking sheet and spread with 1 Tablespoon sour cream each. Press the panko mixture into the sour cream. Place in the oven for 12-15 minutes, until the chicken is cooked through and crispy.

5. Halve the lemon. Cut one of the halves into wedges. In a large bowl, combine 1 Tablespoon sour cream, a large drizzle of olive oil, a squeeze of lemon juice, and a pinch of salt and pepper.

6. When the potatoes are ready, toss them into the bowl with the dressing along with the spinach. Season with salt and pepper.

7. Plate: Serve the crispy chicken Parmesan on a bed of spinach salad with a wedge of lemon for squeezing. Enjoy! ■

# Is it legal to walk in the street?

ever, looking around today, it is clear to see that the sidewalk has become more of a suggestion than a requirement. More and more people every day are walking just by the curb or maybe even practically in the middle of the street. Even though it seems that this is simply just accepted by the law, it is very much illegal.

California Vehicle Code 21956 states, "No pedestrian may walk upon any roadway outside of a business or residence district otherwise than close to his or her left-hand edge of the roadway." It very clearly states the rules of walking in a roadway, but it does not seem that people are always held up to this standard often.

According to www.calguns.net, a forum website about laws in California, a user recalls a time he was stopped and detained for violating VC 21956. They wrote, "I was walking home, stopped and detained for 30 minutes because I stepped off the sidewalk to avoid tree

branches." They claim they felt like they did nothing wrong and explained that to the officer. The officer called his supervisor, who dismissed the pedestrian without any violation given. Another user on the website wrote back, "Trust me he could have arrested you, chances are the supervisor talked him out of it. And yes, it is illegal to walk in the street, that is why there is a sidewalk there in the first place. Simply because you have had officer's drive past you doing it in the past does not make it legal, just not a high priority for them." Overall, the reason most people do not get stopped is because of priority. In fact, if you are getting stopped, odds are the officer is concerned about your safety. Sure, walking on a roadway might not get you a serious ticket, but it might get you a serious injury.

On April 12, 2017 in the city of Eastvale, (bordering Chino), a 28 year old woman, who was walking in the street, was struck by a vehicle and killed. At the time of her death, Eastvale resident,

Janine Chavez, was walking in the roadway on Hamner Avenue south of Amberhill Ave. According to the Riverside County sheriff's department and coroner's office she was not inside a designated crosswalk or on the sidewalk.

According to everybodywalk.org, over 4,500 people in America are killed just crossing the street. The website also claims that over 68,000 people are injured every year from crossing the street. This is even worse in crowded cities like New York, where it is estimated that a pedestrian is killed or injured by a vehicle every two hours.

The Eastvale incident, which resulted in the death of a pedestrian, occurred around 7:45 p.m. when Ms. Chavez was struck by a Honda Accord traveling southbound. The driver of the vehicle was a 51-year-old man from the neighboring city of Ontario according to a press release issued by the Sheriff's Department. Chavez was pronounced dead at the scene.

Sheriff's officials are asking anyone with information about the crash to contact the Jurupa Valley Station's Eastvale Traffic Division 951-955-2600.

The only one who can prevent such actions taking place is the pedestrian. Using sidewalks and obeying traffic signs will keep you safe and lawful. If you want to know more about other laws in the California Vehicle Code, dmv.ca.gov has the complete Vehicle Code on their website. ■

# Mt. SAC Grad Beats Cancer To Walk At Graduation

she walks at Mt. San Antonio College's 71st commencement this Sunday at Citizens Business Bank Arena in Ontario.

"I listened and took everything in that the doctor was saying," Kim said of that day she got the news in February 2000. "But what I wanted to know is how long do I have to live."

The diagnosis was particularly confounding for Kim, a 58-year-old resident of West Covina, because she ate healthy, exercised daily, and had no family history of breast cancer. Fortunately, her doctors caught the cancer early enough and her initial prognosis was good.

At first, her doctors thought the cancer could be eradicated in a matter of months. Yet as it turned out, Kim would battle breast cancer for the next three years, which included five surgeries, chemotherapy, radiation treatments five days a week, and the removal of her thymus gland. Complications arose and she was eventually put on long-term disability after more than 20 years with the Los Angeles County Sheriff's Department as a stenographer, word processor, and supervisor. Because her cancer was so unusual in the way it progressed and behaved, Kim's oncologist sent her case to the USC Keck School of Medicine to be studied by the USC Norris Cancer Center. And she endured all of this as a single parent raising two daughters.

While she was still undergoing chemotherapy, Kim decided

that the first chance she got she was going to go back to school.

"I always wanted to go to college. It finally got to the point that I said to myself, 'I am going to do the things I've always want to do no matter what,'" she said.

She enrolled in an Administration of Justice course at Mt. SAC in fall semester 2003 and began living her dream. She joined the Honors Program, received scholarships, and was even listed in "Who's Who in Community Colleges."

But just when everything was looking bright, her dream was interrupted as tragedy struck again. Her grandson, born prematurely, passed away in 2007. Her mother passed in 2009, and her sister passed in 2010. Also in 2010, the cancer came back.

"It was worse than the first time because the doctors now used a much more aggressive treatment program," said Kim, who had to put her education on hold again.

More surgery, chemo, and radiation treatments followed and left her feeling fatigued and unable to focus due to the side effects of the treatments. The return of the disease seemed to increase her determination, and she battled cancer for the second time until she could eventually resume her studies in 2013. It was then that she decided to go into social work to help people as her second career.

Today, Kim is cancer free. Her two daughters, also previous Mt. SAC students, will watch as their mother graduates with the Class of 2017

and receives five degrees—including associate degrees in Administration of Justice, Sociology, Social and Behavioral Science, and Kinesiology.

"I'm mainly doing it for my granddaughter, Rielynn, so that she can see that no matter how old you are or what obstacles you face, you can do it."

Kim actually began attending Mt. SAC briefly in 1997, so when she graduates, she will have taken classes there for parts of 20 years.

"I've been here at Mt. SAC so long it feels like I'm losing my lifeline. I am definitely going to miss Mt. SAC," she said.

Kim plans to continue her education at Cal State Fullerton to pursue a bachelor's degree in Human Services and Medical Social Work. She wants to go on to earn a master's in Marriage and Family Counseling and ultimately help other cancer patients.

"I learned about all the resources that are out there for patients, and I wanted to pass on that knowledge to others," she said. "I've encountered several patients who did not have resources or did not know where to obtain resources to help them cope with their diagnosis and everyday life challenges associated with being a cancer patient."

Now her dream is to help others who face circumstances similar to her experience and to pass on what she has learned.

"No matter such issues you might be dealing with, don't let anyone or anything keep you from your dream. There is always hope to achieve whatever you want," she said. ■


