**Walnut** - A face mask, hand sanitizer, laptop, ring light, and Starbucks latte sit on Social Studies teacher Katy Larson's desk as she delivers a Roots of Civilizations online lesson from her empty South Pointe Middle School classroom on Tuesday.

"I am so happy to see my students and work with them - even if it is over Zoom!" she shared.

Courageous and determined educators are working diligently to connect with students through distance learning due to the COVID-19 pandemic.

Social studies teacher Eric Shin was able to enlarge student's virtual Zoom images by cleverly projecting on a whiteboard pull-down screen.

"A teacher friend shared the tip with me!" he said at his new workspace designed with two laptops, stool, and world globe neatly arranged on empty desks in the center of the classroom.

Shin spent time during the first week of school getting to know students and helping them learn how to regulate emotions.

"It's so necessary right now," he shared of the priority to create a positive classroom culture.

"Then the kids started asking, 'When are we going to actually going to start history, Mr. Shin?'" he said.

"So, I told them 'this is the day - I hope you enjoy it!'"

His 7th grade classes are now learning about Mesoamer-

#### THE DOMESTIC KINDNESS TEAM

**Diamond Bar** - There is an epidemic in homes throughout the world, in every culture. According to the CDC, one in 4 women and one in seven men have been severely physically abused by an intimate partner.

Churches have traditionally been a place for people to seek help when facing personal struggles. This is why it's important for them to learn about the dynamics of domestic abuse and how to respond in a way that is helpful and not harmful.

Domestic Kindness equips churches to be part of the solu-

tion to domestic abuse. We educate through workshops, Bible studies, and sermon suggestions. We train a permanent group of church volunteers at each church to keep educating the church and to point people to the right resources when necessary.

Education about domestic abuse is necessary for the prevention of abuse. It encourages kindness and directs people away from disrespectful behavior. Education also leads to healing for those who have never been able to talk about their

### Diamond Bar High Freshman Runs 30 Days to Feed Families

**Diamond Bar** - After months of being cooped up in quarantine, incoming Diamond Bar High School freshman L'Mio Edwards decided to get moving to help make a difference during the global pandemic.

During the summer, the talented track star ran a 5K (3.1 miles) for 30 straight days in her quest to feed families impacted by COVID-19.

Step by step, her efforts totaled 93 miles while raising funds for the New Earth non-profit organization that distributes free weekly groceries.

"People need to eat, espe-

cially during this coronavirus," the 14-year-old said.

The #5KaDay4Food Challenge kicked off May 26 and has netted \$9,600, just a few hundred dollars shy of her \$10K goal.

"I've been running since around the third grade," she said during a recent KNBC interview.

"After running for so long I thought I might use it for something if I'm going to be stuck at home."

L'Mio began preparing her mind and body for the feat by completing a 6K each day for two and a half weeks prior to the event.

es 368-369 are due tomorrow night.”

Math teacher Deb Brady utilizes the free WhiteBoard.fi program that allows her to monitor her geometry students’ work live during class.

“Nicely done, you guys are getting it,” she said to the laptop screen as students solved segment addition problems on August 17.

“So far, it’s working!” she said.

Science teacher Megan Kojder’s students had a chance to get creative while designing personal Bitmoji scenes.

“If you have a question ask me in the chat!” she said to the faces of her online group.

“Give me a thumbs up if you’re there,” she prompted.

“The kids are using science, even though they didn’t realize it, by learning the CER (Claim, Evidence, Reasoning) method of asking and answering questions,” Kojder explained.

During Zoom breakout groups, students are able to make correct inferences (using the CER method) based on their scenes.

Teaching from home, Cassie Lambert reviewed an Elements of Literature lesson with 40-seventh grade Advanced Language Arts students before they created a digital infographic to help teach content to other classes.

“So far, distance learning is going better than expected,” Larson commented.



“Together, we’ve sorted out the hiccups that have come along as a class.”

Larson said her students have been “an amazing help.”

“They love to solve technical problems and work with each

other to find a solution.”  
“And they are demonstrating an immense amount of compassion, patience, and resilience.”

# Pastor's Corner: The Man In The Mirror

Many years ago, I heard a pastor share his story about his relationship with his teenage daughter. He was discouraged and concerned that his daughter was angry and frustrated with him. One day he took his whole family to a local park. As they sat on some tree stumps, he asked his wife and each of their children this question – “What changes do I need to make in my life that can help heal our family?” He said it hurt deeply as each of them shared some of their frustrations with him. His teenage daughter was the most vocal. She told her father that he was too busy and he never listened to her.

After each of them shared, he told them he needed some time to be alone and think about what they had said. As he got up to leave, his daughter stopped him and said she

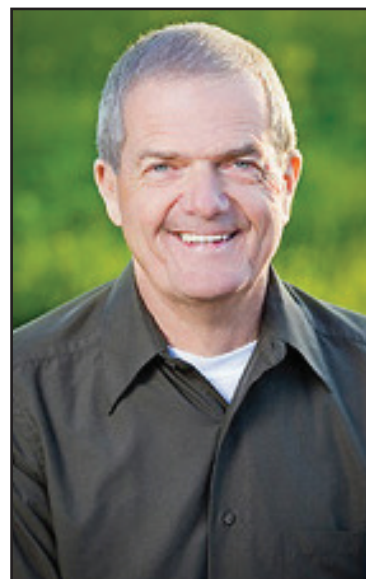
needed to ask him the same question. “What changes did she need to make in her life?” This was a turning point in their strained relationship. His heart was softened and he began to make some changes in his schedule and he spent more time with his daughter. The daughter’s heart was softened and she began to make changes in her life too.

There is a passage in the Bible where Jesus said, “Before you try to remove the speck from your brother’s eye, you need to remove the log from your own eye” (Matthew 7:1-5). If there is a problem in your family, marriage or other relationship – the place to begin is in your own life. Look in a mirror and ask yourself this question – what am I doing that is causing problems in our relationship? What changes do I need to make in my life that will help heal the wounds and restore

my relationship with others?

There is a song from the 1980’s written by a famous singer with the title – Man in the Mirror. Some of the words are, “If you want to make the world a better place, take a look at yourself and then make a change. I’m starting with the man in the mirror. I’m asking him to change his ways”.

I love the phrase – Changed people change people. I believe that when you make positive changes in your life it will produce positive changes in others too. Your words, attitudes and actions can have a positive or negative impact on others. Let me encourage you to look in the mirror and ask yourself – what changes do I need to make in my life. You can ask your spouse, children or a trusted friend too. Pray and ask God to reveal some things to you that you need to change in your life with His help. You



will be glad you did and those around you will too.

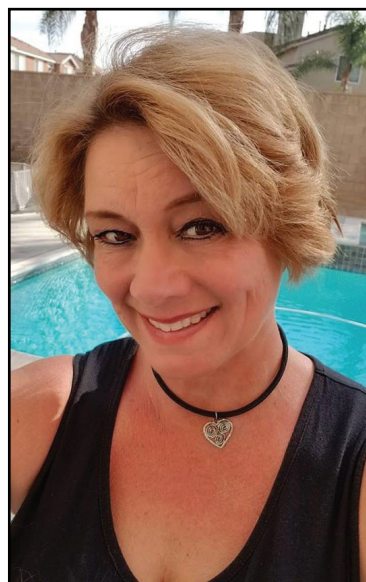
Now I am all for safety and health, so when it is safe to go back, we will go back to school. Though try and explain that to an autistic child.

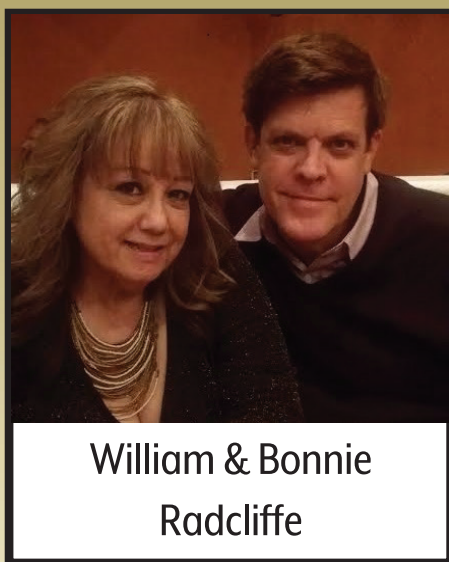

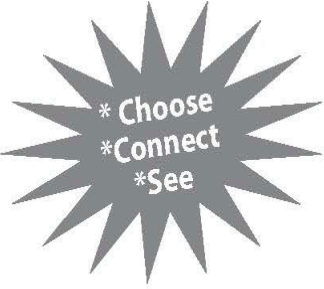

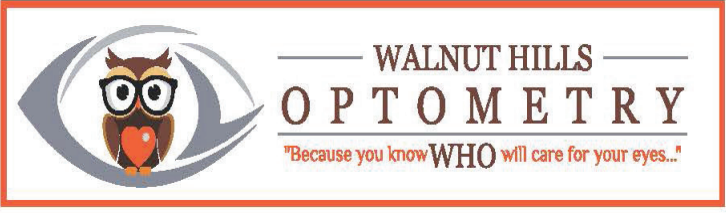
