Gomez, a first generation college student, was recently hired at Brenner Fiedler as an apprentice where he is helping assemble pumps and wiring medical machinery. This allows him to learn the basics of wiring and electrical work while making a livable wage. Gomez's long-term goal is to become an engineer. He finds joy in building and is grateful that the LAUNCH program allows him the opportunity to learn, earn, and work towards his ultimate career goal.

"The apprenticeship program helped me get to this step," said



Gomez. "I recommend anyone interested in this model to enroll because it is a great opportunity to explore different options while getting paid."

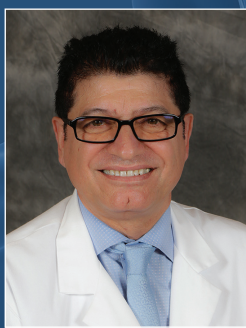

Pastor's Corner: Strong

"In the day when I cried out, You answered me, and made me bold with strength in my soul." Psalm 138:3

Daniel faced a powerful king and he faced Lions with great strength. When we read of Daniel facing Lions in the Lion's den, you have to wonder how Daniel was able to do it. Yes, he trusted God, but something brought him to the place of trust. We are told in Daniel 6 that a law had been passed prohibiting prayer to any god or any human other than the king. In fact, the punishment for breaking this law was being thrown to the Lions. It appears that what Daniel does next is what gives him strength. "When Daniel learned that the law had been signed, he went home and knelt down as usual in his upstairs room, with its win-

dows open toward Jerusalem. He prayed three times a day, just as he had always done, giving thanks to his God" (Daniel 6:10 NLT).

Scripture tells us that Daniel had always done this. Daniel was wired to pray when things got difficult. If obeying God meant certain death, he trusted God. It causes me to think about the things I do when things get difficult. I believe Daniel knew one of the keys to standing was actually kneeling. We are encouraged to resist worrying about anything; instead, pray about everything (Philippians 4:6 NLT). Daniel did just that. Daniel prayed and God gave him the strength to stand in the Lions Den.

As we read, Daniel trusted God, and God shut the mouths of the Lions. What are you facing today? Does it feel like a mountain? Do what Jesus did

and go to the mountain and pray. God is able to shut the mouth of the enemy. God is also able to move mountains (Matthew 17:20). God is able to make you strong (Philippians 4:13). Pray and walk in His strength today.

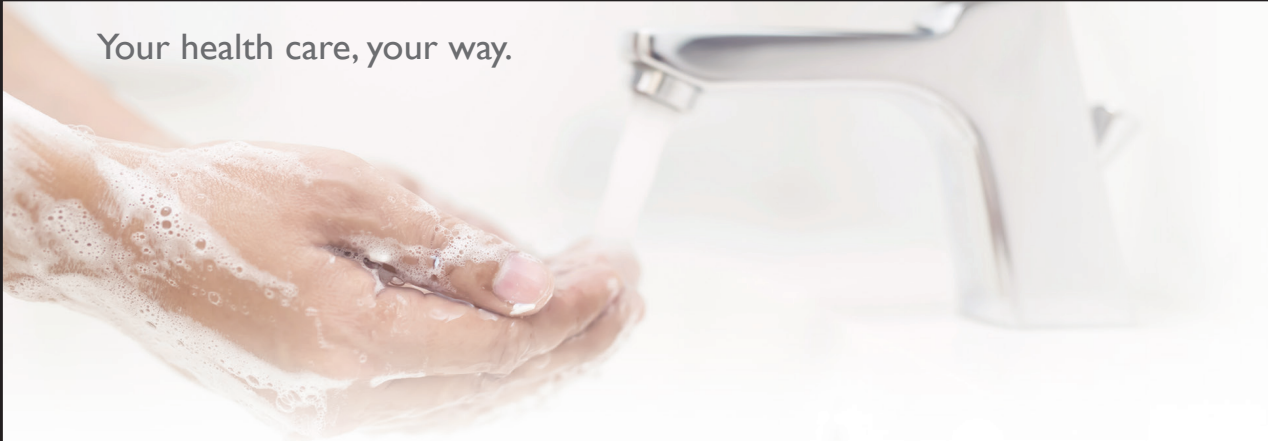

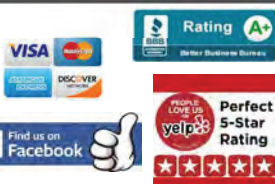

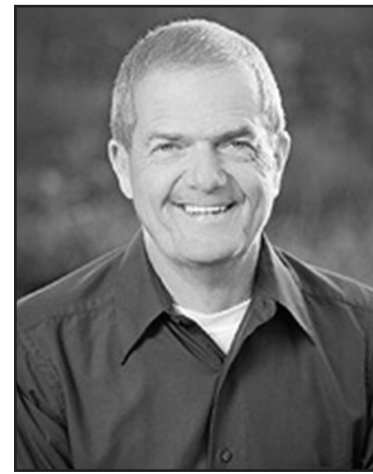

A man named Abraham faced a similar test. His wife was beautiful. He told her to lie and tell people she was his sister. He told the same lie when he was asked about her. Abraham was afraid someone might kill him and take his wife (Genesis 20). Years later his own son Isaac did the same thing following of his father's example (Genesis 26)!

I know people are more im-

portant than pumpkins. I believe it is better to tell the truth and face the consequences than to tell a lie. There is a verse in the Bible that says, "Put aside falsehood and speak truthfully" (Ephesians 4:25). Your reputation is on the line and your children may follow your example. 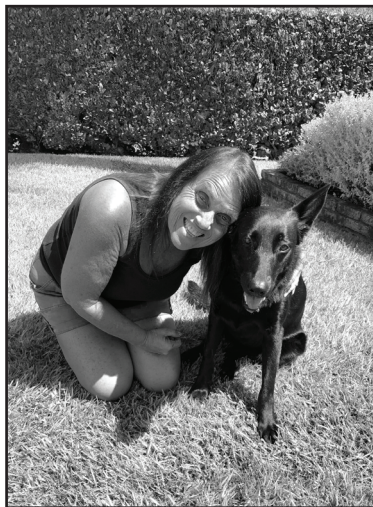

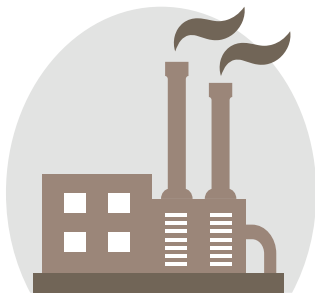

Salts and other dissolved particles in our groundwater are too high for consumption without treatment. The salinity in water is measured in "Total Dissolved Solids" (TDS).



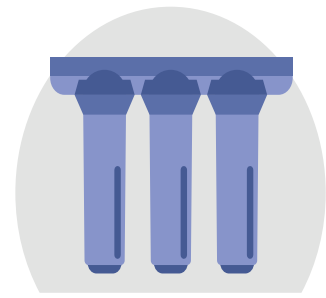

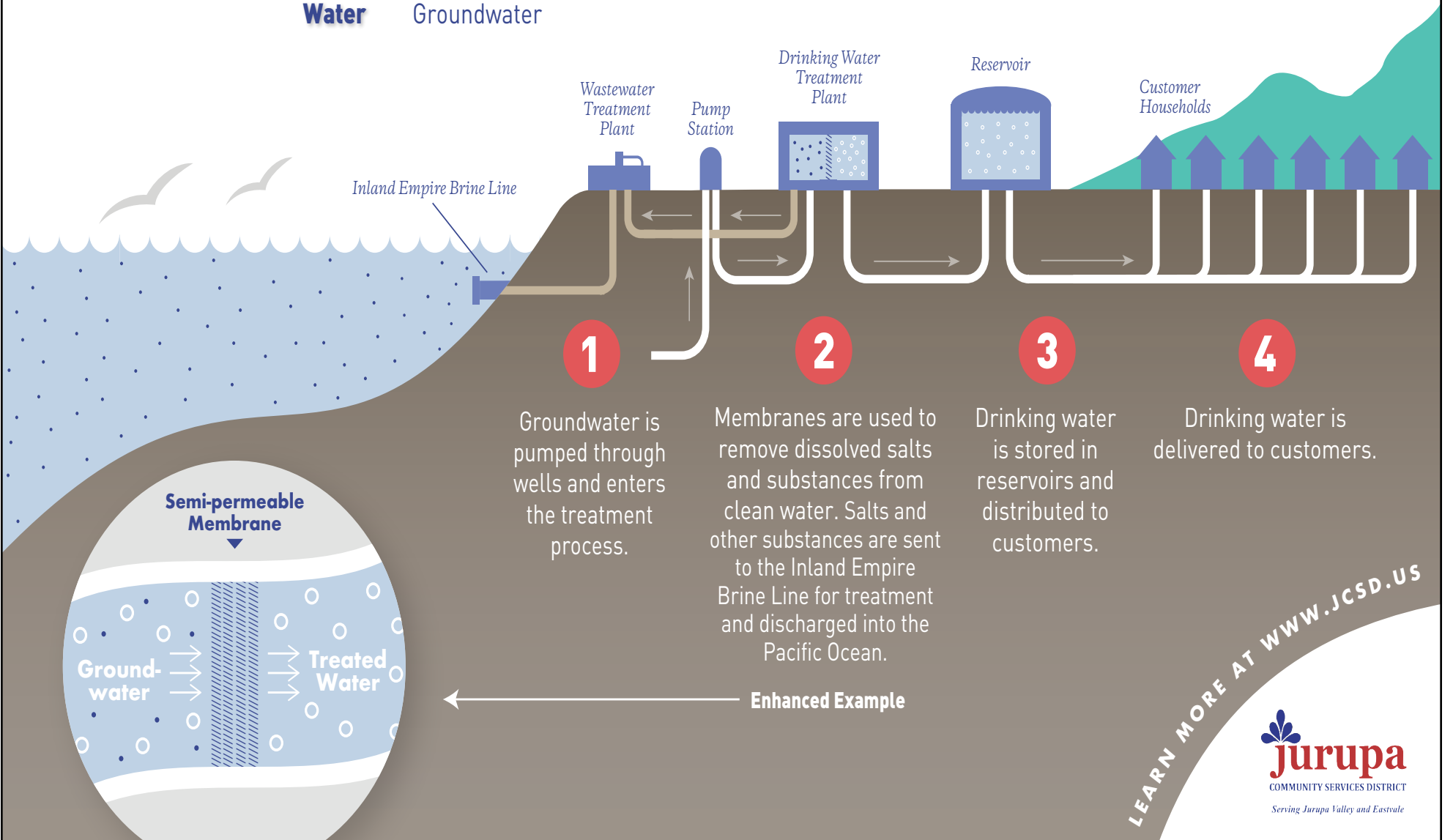
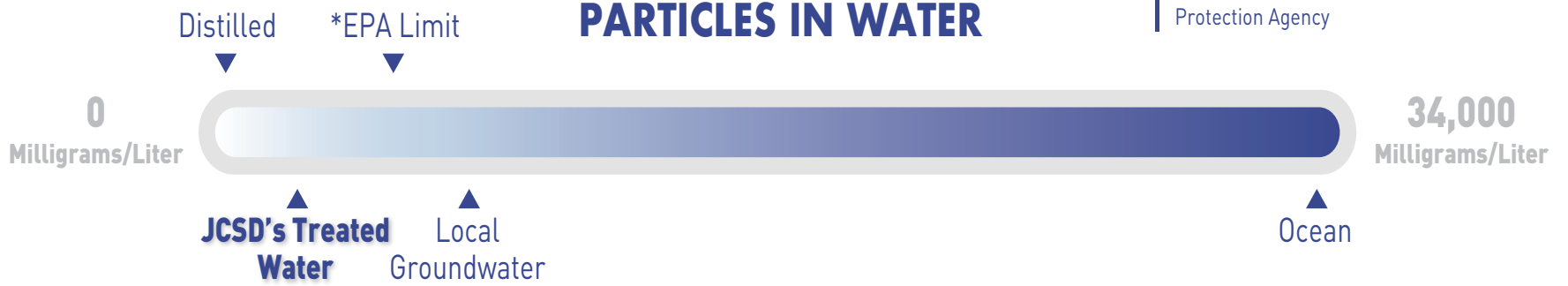
