# 9 Arrested At Local DUI Checkpoints

**STAFF REPORTS** 

Eastvale/Norco - Nine people were arrested at recent Driving Under the Influence (DUI)/Driver's License Checkpoints that took place in Eastvale and Norco.

The first checkpoint was on Friday, August 2, on Hamner Avenue and Third Street in Norco between 7 pm and 3

The Riverside County Sheriff's Department, Norco Station, arrested two people for

driving under the influence of Station, arrested five people alcohol and one person for a felony arrest. Five Field Sobriety Tests (FSTs) were conducted, 14 citations were issued for unlicensed drivers, and two vehicles were stored and impounded, out of the 551 vehicles screened.

The second checkpoint took place on Friday, August 16 on Schleisman Road and Archibald Avenue in Eastvale between 7 pm and 3 am.

The Riverside County Sheriff's Department, Jurupa Valley for driving under the influence of alcohol and one for a miscellaneous misdemeanor. Thirty-eight Field Sobriety Tests (FSTs) were conducted, 23 citations were issued for unlicensed drivers, and six vehicles were stored or impounded out of the 1,106 vehicles screened. Seventy-four vehicles were also subjected to a secondary screening.

"DUI checkpoint locations are determined based on reported incidents of impaired driving-related crashes," according to a Riverside County Sheriff's Department news release. "The primary purpose of DUI checkpoints is to promote public safety by taking suspected impaired drivers off roads."

Both the Norco and Jurupa Valley stations remind the public that "impaired driving is not just from alcohol. Some pre-

# New Cell Phone Policy At CNUSD

Eastvale - The Corona Norco Unified School District (CNUSD) is working on implementing a new cell phone policy, but they are asking for parent, student, and staff feedback.

The new cell phone policy is expected to "enhance the educational environment and focus during instructional time" says a CNUSD news release.

"In alignment with State Legislation AB 272 & AB 3216 (proposed) all Districts are expected to have a cell phone policy in place by July 2026." stated the news release. "Additionally, Governor Newsom has requested School Districts take action sooner than the deadline and has granted Districts

the authority to regulate smart

phones during school hours." CNUSD announced that

they started working on implementing this new policy under the direction of their Board of Education.

The District's hope is to "maximize student learning through elimination of distractions during instructional time. This may look different at var-

ious grade levels and at different schools." They stated that the new policy will not ban cell phones on campus, but instead will aim to limit cell phone use while on campus and during instructional time. They discussed that most phone poli-

Incident: Major Injury Traffic Collision

Date: Aug. 11, 2024 Location: Norco

Details: On Sunday, August 11, 2024, at 9:20 p.m., deputies assigned to the Norco Sheriff's Station responded to the area of Hidden Valley Parkway and El Paso, Norco, regarding a major injury traffic collision involving a vehicle and a tree. When deputies arrived, they located the driver inside the vehicle with significant injuries. Deputies rendered medical aid to the driver, who was safely extracted from the vehicle by Cal-Fire. The driver was treated at

the scene and subsequently transported to a local hospital in critical condition.

The Jurupa Valley Sheriff's Station Traffic Team responded to the scene and assumed the investigation. The cause of the collision is still under investigation, and it is unknown if alcohol or drugs were a factor. The driver's identity is being withheld pending next of kin notification.

The collision investigation required the temporary closure of Hidden Valley Parkway between El Paso and Via

Incident: Assault With a Deadly Weapon Investigation Leads to Seizure of Multiple Firearms

Date: Aug. 2, 2024 Location: Jurupa Valley Details: On August 2, 2024, at 12:59 p.m., Jurupa Valley Sheriff's Station deputies responded to the area of Pats Ranch Road and Limonite Avenue, Jurupa Valley, regarding a disturbance. During the investigation, deputies learned the suspect, 31-yearold Yorgan Rios of Jurupa Valley, pointed a firearm at the victim during a dispute. Rios then fled the area in a black SUV.

Deputies later located Rios in his vehicle and conducted a high-risk stop. Rios was detained and found to be in possession of ammunition but no firearm. A search warrant was obtained for a residence on the 11000 block of Dane Drive, Jurupa Valley, to search for the firearm used during the assault. During the service of the search warrant, 17 firearms, ammunition, and other evidence related to

the assault were found and seized. Rios was arrested and booked at the Robert Presley Detention Center for assault with a deadly weapon, with bail set at \$25,000.

Incident: Fatal Traffic Collision

Date: July 31, 2024 Location: Eastvale

Details: On Wednesday, July 31, 2024, at about 9:52 p.m., deputies assigned to the Jurupa Valley Sheriff's Station responded to the 5300 block of Goodman Way, Eastvale, regarding a major-injury traffic collision involving a vehicle into a building. When deputies arrived, they located the driver and sole occupant of the vehicle suffering from major injuries. Deputies began rendering medical aid to the driver until the arrival of the Riverside County Fire, who took over life-saving measures. The driver ultimately succumbed to the injuries sustained during the collision and was pronounced deceased at the scene.

The Jurupa Valley Sheriff's Station Traffic Collision Reconstruction Team responded to the scene and assumed the investigation. The cause of the collision is still under investigation, and it appears drugs were a factor. The driver's identity will not be released at this time, pending

notification to the next of kin.

The collision investigation required the temporary closure of Goodman Way in order to process the scene and collect evidence. Incident: Vehicle Burglary / Jugging

Date: July 23, 2024 Location: Norco

Details: On July 23, 2024, at 12:26 p.m., Norco Sheriff's Station deputies responded to a vehicle burglary near the 1100 block of Hamner Avenue in Norco. Upon their arrival, they were told the victim had withdrawn a large amount of

money at a local bank and placed it inside the center console of their vehicle before going into a business.

During the investigation, deputies learned while the victim was inside the business, an unknown female followed him as an unknown male suspect walked up to the victim's vehicle, broke the door lock, and stole the victim's money from the center console. The two suspects then left the area prior to the deputy's arrival.

The mode of operation in this type of theft is commonly referred to as "Jugging."

Following investigative leads, the Norco Special Enforcement Team (SET) learned the suspect vehicle was in the Moreno Valley area. The Norco SET Team and Moreno Valley Sheriff's Station motor deputies locat-

ed the vehicle and detained the suspects. Evidence of the crime, including burglary tools and clothing items matching surveillance footage, was located inside the vehicle. The suspects, 43-year-old Oscar Javier Piraquive Rubiano and 41-year-old Darly Mercedes Gutierrez Cipagauta, residents of Los Angeles County, CA, were arrested and booked at the Robert Presley Detention Center for burglary, burglary tools, and conspiracy. Their bail was set at \$500,000.

cies implement a "silenced and away" model, meaning they are not allowed to have them out during a defined portion of the day. "For high school this may mean no phones out during class/instructional time, but put away in a bag, backpack or pocket," states the CNUSD FAQ page. "For intermediate

and elementary students, this may mean phones silenced and away in a backpack all


CNUSD is still working to establish disciplinary guidelines if students are caught using their phone. But what they do know is that cell phones will be accessible during an emergency. Also, students on an IEP will still have access to their devices, as defined in their IEP, especially if they utilize tools on a cell phone.

CNUSD is asking parents, students, and staff to provide feedback by August 31 to help in this decision-making process. They hope to implement a District Cell Phone Policy by January 2025.
